Glazing: Covering with suitable U.V. stabilized polythene sheet of 200 micron thickness, the sheet is to be fixed with aluminium profile and high carbon steel spring action wire of 2-3 mm zig-zag for quick removal and fixing. Doors and End Frame: Two number annex doors (1 No. Sliding inside & 1No. fixed with hinges outsides) size 1m x 2 m made FROM 32 MM X 32MM Square pipe, End Frames fabricated of G.I. pipes. (Annex size: 2mx3m) both Doors are be installed with Annex. - 7 The price quoted should be strictly according to the specifications stated above.
- 8 The quotation should be addressed to the Comptroller, CSKHPKV, Palampur however, it should reach in the office of the **Programme Coordinator, Krishi Vigyan Kendra, Mandi at Sundernagar -175019** in sealed cover and super- scribed "**Quotation for Construction/installation of Polyhouse at KVK Mandi** on or before **16.06.2022** by 5.00 PM and will be opened on **17.06.2022** at 11.00 AM in the office of **CPDU (Comptroller's office)** in the presence of the representatives of the firms, if they wish to be present. The quotation received after due date will not be accepted.
- 9 The university reserves the right to accept or reject the quotations without assigning any reason.
- 10 The payment will be made after satisfactorily installation & inspection Report of the material to be conducted by the inspection Committee so constituted for the purpose by the KVK/University.
- 11 No condition of advance payment or payment in cash will be considered.
- 12 The quantity can be increased or decreased.
- 13 If the total value of the purchase exceeds Rs. 1.00 Lakh, the quotation should be accompanied with an earnest money i.e. @ 2% of the estimated value of goods in the shape of F.D.R/DD duly pledged in the name of the comptroller, CSKHPKV, Palampur. The earnest money if any, already deposited/lying in the office of the undersigned will not be considered for current quotation. **The quotation without EMD will not be considered.**
- 14 Performance securities @ 5% of the whole amount of the total supply will be obtained from the successful bidder before placing the supply order. The earnest money already deposited shall form part of performance security.
- 15 The E-way bill is to be required along with actual bill.
- 16 The GST is applicable @ 5% in the CSKHPKV, Palampur against GST Concessional Certificate being a Research University.
- 17 COVID-19 SOPS/Instructions issued by the Central/State Govt. Should be adhered strictly by the Suppliers/firms.
- 18 The Warranty period of polyhouse should be mentioned in the quotation.
- 19 All disputes shall be within the jurisdiction of Palampur Court.
