3. Quotations will be received in the office by post/by hand to reach up to 3:00 PM on 30/09/2022 and will be opened on 30/09/2022 at 3:30 PM, in the presence of the bidder or their agents, if present.
4. The rates quoted should include the cost of transportation to the destination i.e be FREE DELIVERY AT SITE (FDS), DGCN College of Veterinary and Animal Sciences, Palampur, Kangra, H.P. 176062.
5. The rates should be quoted including all other charges, such GST considering the hospital supply, other taxes (sales tax, excise tax, etc.) packing and forwarding, if any. Nothing will be paid extra.
6. The delivery of the items is to be made within 45 days of approval of the rates, which will be communicated through a valid supply order, otherwise the order will be cancelled forthwith at your risk expenses and order will be placed with the next firm.
7. The prices quoted should strictly be adhered to the specifications given in the list.
