TERMS & CONDITIONS:-

1. The rates are F.O.R. University HQ at Palampur.
2. The rate quoted should be inclusive of all the charges.
3. GST may be shown separately in the quotations.
4. The quantity of material can be **increased/decreased**.
5. The rate quoted should be strictly according to the specifications stated as above.
6. On the covering envelop "Quotation Weedicide (Vesta)" should be written.
7. The undersigned reserves the right to accept or reject the quotations without assigning any reason.
8. The quotations shall be opened on **12.10.2022 at 11.00 A.M** in which the bidders can remain present.
9. The payment will be made after satisfactory inspection report of the material to be conducted by the Inspection Committee so constituted for the purpose by the University and passing the bill from the audit.
10. There should be no condition of Advance payment.
11. The validity period of quotations should be for six months from the date of opening the quotations.

If the total value for the purchasing of above good quality seeds exceeds Rs.1.00 Lakh, the quotation should be accompanied with an earnest money i.e. @ 2% of the estimated value of goods in the shape of F.D.R. duly pledged in the name of Comptroller, CSKHPKV, Palampur. The earnest money if any, already deposited/lying in the office of the undersigned will not be considered for current quotation. **The quotation without EMD will not be considered.**
13. Performance security @ 5% of the whole amount of the total supply will be obtained from the successful bidder before placing the supply order. The earnest money already deposited shall form part of performance security.
