- 14- If the total value for Floor mat of the above mentioned / publications exceeds Rs.1.00 Lakh, the quotation should be accompanied with an earnest money i.e. @ 2% of the estimated mat of goods in the shape of F.D.R. duly pledged in the name of Comptroller, CSKHPKV, Palampur.
