The quotation (preferably with brochure & price list, if available) should reach the O/o "The Head, Department of Tea Husbandry & Technology, CSK HPKV, Palampur 176 062, HP" by **30.05.22 upto 5.00 PM** in sealed cover super-scribed as "Quotation due on 30.05.22" and have complete address of the sender. The quotations will be opened on **31.05.22 at 11.00 AM** in the office of the undersigned in the presence of the quote firm or authorized representative, if wish to be present.
2. Rates should be quoted **F.O.R. "Tea Factory of the Dept. of Tea Husbandry & Technology, CSK HPKV, Palampur 176 062, HP"** (i.e., inclusive of all charges whatsoever).
3. GST No. of the firm should be clearly mentioned in the quotation.
4. GST (%) should be clearly & separately shown. No 'C' & 'D' form will be issued by this department. This University is an R & D State Educational Institution. Concessional GST @ 5%, if otherwise applicable/admissible, exemption certificate will be issued by the University to the successful bidder.
5. Authorized dealer certificate (if available) and Guarantee/Warranty should be clearly mentioned.
6. Quotation should be accompanied with a refundable Earnest money deposit (EMD) @ 2% of quoted rates (if it exceeds Rs 1.00 lacs) in the shape of FDR/TDR/DD in favour of the Head, Dept of Tea Husbandry & Technology, CSK HPKV, Palampur 176062, HP.
7. A satisfactory user report/certificate, from the institution/tea factory/department where the said machine has been earlier supplied & installed by the firm, if any, should be attached with the quotation.
8. A refundable Performance security @ 5% of the awarded material, will be obtained from the successful bidder at the time of supply of the machine.
9. Supply & installation of the machine is to be effected immediately. Therefore, quotation should be submitted only if the item can be supplied promptly on demand.
10. Payment will be made after successful installation and demonstration of functioning of machinery (trial run) by the supplier and upon satisfactory inspection report of the Inspection Committee constituted for the purpose.
11. Conditional quotation will not be considered.
12. The E-Way bill will be required along with Actual Bill at the time of supply of the material.
13. Cutting/overwriting should be avoided and, if any, should be legibly signed by the authorized person.
14. If any given date happens to be a holiday, next working day will be considered for the purpose.
