9. The payment will be made after satisfactorily inspection report of the material to be conducted by the Inspection Committee so constituted for the purpose by the University and passing the bill from the audit.
10. There should be no condition of Advance payment.
11. The validity period of quotations should be for six months from the date of opening the quotations.

If the total value of the for printing of above booklet exceeds Rs.1.00 Lakh, the quotation should be accompanied with an earnest money i.e. @ 2% of the estimated value of goods in the shape of F.D.R. duly pledged in the name of Comptroller, CSKHPKV, Palampur.
