OFFICE MEMORANDUM

Subject:- Enhancement of Uniform allowance to the Nursing Personnel  
The matter regarding enhancement of uniform allowance to the Nursing Personnel has been under consideration of the Govt. for some time past. After careful consideration of the matter and in supersession of all the previous notifications issued in this behalf from time to time, it has been decided by the Govt. to enhance the Uniform allowance to the following Nursing Personnel of the Department from Rs. 40/- PM to Rs. 300/- PM, which will be applicable w.e.f. 1<sup>st</sup> January, 2007:-

1. AD (Nursing)
2. P.N.O.
3. Nursing Superintendent
4. Matron
5. Ward sister
6. Sister tutor
7. Staff Nurse
8. Public Health Nurse.

The aforesaid allowances shall also be admissible during the leave period (except Extra Ordinary Leave) of all the Nursing Personnel mentioned above. This issues with the prior concurrence of the Finance Department obtained vide their U.O.No. Fin-C-B(15)-2006 dated 12-11-2006.
