Meeting with HPAUTA to discuss the demands/issues raised by the Secretary HPAUTA was held on 05.03.2022 at 03.30 PM under the chairmanship of the Hon'ble Vice-Chancellor. The following were present:-

President, HPAUTA thanked the Hon'ble Vice-Chancellor for taking the demands of HPAUTA in positive way and giving time to the executive for deliberating the issues. Thereafter the demand charter was taken up for discussion as under:-

1.	Switching over from CPF to GPF	Swad
	The HPAUTA was informed that the matter is under consideration.	
2.	Unnecessary objection by the University audit	Swad
	After detailed deliberation, it was decided that the Comptroller and the Assistant Controller (State Audit) camp at Palampur shall jointly device a check list and will circulate the same in the University to <u>avoid delay in adjustment of Advances</u> etc.	
3.	Taxi fare as per govt. of Himachal Pradesh	Swad
	It was decided that the Comptroller will look into the matter and issue necessary circular to use own car within the State during official tours as per provision and entitlement.	
4.	Advances to be settled on priority basis	Swad
	It was informed to the HPAUTA that that the Comptroller and the Assistant Controller (State Audit) camp at Palampur will look into the matter.	
5.	Implementation of UGC scale in the University	Swad
	It was informed to the HPAUTA that the University will immediately implement the scales after its notification by the state Government.	
6.	Unnecessary objections raised by the Directorate of Research	Swad
	After detailed discussion it was decided that the Comptroller will discuss the issues raised by the association with the Director of Research
