Edn. 6/27/2014-HRD dated 30th July, 2019 on the above subject, approval of competent authority is hereby conveyed for revision of emoluments payable to Junior Research Fellows (JRFs)/ Senior Research Fellows (SRFs) pursuing Ph. D. program in ICAR-AU System and Senior Research Fellows (SRFs)/ Research Associate (RFs) working in various schemes of ICAR with the following details:

The revised emoluments will take effect from the date of issue of this OM. The House Rent Allowance (HRA) will be given as per existing Central Government rates applicable in various cities/locations where JRF/SRF/RA are working in ICAR funded projects. The additional expenditure on this account will be met from the sanctioned budget of the respective schemes.

The other terms and conditions issued vide Council's guidelines No. Ag. Edn. 6/27/2014-HRD dated 30th July, 2019 for JRFs/SRFs/RAs with regard to service conditions/ entitlements etc. remain same.
