OFFICE MEMORANDUM

Subject:- Grant of Interim Relief to the regular employees of the State Government of Himachal Pradesh.

I am directed to invite a reference to this Department's Office Memorandums of even number dated: 2<sup>nd</sup> August, 2016, 4<sup>th</sup> August, 2017 & 9<sup>th</sup> February, 2018, on the subject cited above and to state that the Governor, Himachal Pradesh, is pleased to grant INTERIM RELIEF @ 4% of the Basic Pay (Pay in the Pay Band + Grade Pay) with effect from 1<sup>st</sup> July, 2018, to be paid, in cash, with the salary of the month of August, 2018, on 1<sup>st</sup> September, 2018, to the regular employees of the State Government of Himachal Pradesh excluding officers of All India Services. The total 21 % interim relief (5%, 4%, 8% interim reliefs granted earlier and this 4% additional interim relief) shall not be treated as pay for the purposes of calculation and payment of any other kind of allowances including Dearness Allowance. The total amount of 21% interim relief will be absorbed in the future revision of pay scales to be allowed by the State Government.
