**OFFICE MEMORANDUM**

Subject: Amendment of existing provisions and revision of entitlement of Hotel rent to the State Government employees.

The matter regarding amendment of existing provisions of entitlement of Hotel rent was receiving attention of the Government for some time. After careful consideration of the matter, the Governor, Himachal Pradesh, in partial modification of this Department OM No. Fin(C)-B(7)-14/98, dated 8<sup>th</sup> December, 1998 and subsequent O.M. dated 2<sup>nd</sup> June, 2006 and OM of even No. dated 20<sup>th</sup> April, 2012, is pleased to order amendment of existing provisions and revision of entitlements/rates of Hotel Rent in respect of State Government employees in the manner as under:-



The above rates are the maximum limit for re-imbusement of Hotel rent to the State Government employees who stay in Hotels, Guest Houses run on commercial lines while on duty as per their entitlement subject to the production of actual receipt of Hotel rent. There will, however, be no re-imbusement for food.

The employees, who do not succeed in securing accommodation in Himachal Bhawan/Circuit Houses/Rest Houses etc. while on tour and have to stay in Hotels and Tourist Banglows etc. run on commercial lines, shall be re-imbursed actual Hotel rent upto the maximum as prescribed above.


