OFFICE ORDER

In pursuance of the decision of the Hon'ble HP High Court, Shimla in CWPOA No. 106/2019 titled as Himachal Pradesh Agriculture University Laboratory Staff Welfare Association Vs. Vice-Chancellor, CSK HPKV, Palampur & others and on the recommendations of the Finance Committee vide item No. 129(13) of its 129th meeting held on 06.10.2022 which were further approved by the Board of Management vide item No. 3.6 of its 126th meeting held on 06.10.2022, the Vice-Chancellor has been pleased to grant revised pay scales and designations to the existing **Laboratory Attendants w.e.f. 1.1.2006 and revised pay scale from 01.11.2012** in the following manner:-

1.	Laboratory Attendant	Junior Technician (G-IV)	Rs. 5910-20200+Grade Pay of Rs. 1900/-	Rs. 10300-34800+Grade Pay, of Rs. 3200/- with initial pay of Rs. 13500/- as in the case of Clerk
2.	-do-	Jr. Technician (G-IV) (50% ratio)	Rs. 5910-20200+Grade Pay of Rs. 2800/- as in the case of Clerk	Rs. 10300-34800+Grade Pay of Rs. 3600/- with initial pay of Rs. 14430/- (50%). This pay band is to be given to the 50% of the total number of Junior Technician (G-IV) in a cadre after a minimum period of 05 years of service as in the case of Junior Assistants.

On grant of above designation and pay band, the existing incumbents concerned will continue to discharge the same duties /responsibility as such prior to grant of above pay band/designation.

The benefits of these scales will be admissible on actual basis w.e.f. 01.11.2012 i.e. due date to fill realization to the above categories, in order to implement the judgement of the Hon'ble High Court of H.P, Shimla referred to above. After granting the pay scale w.e.f. 01.11.2012 on the analogy of HPU, Shimla to the Jr. Technicians (Grade-IV), the benefits if any, granted under ACPs (under 4-9-14 etc.) to them after 01.11.2012 will be adjusted according to the instructions of the Finance Department in the matter of ACPS from time to time.

This office order is issued in supersession of earlier office order No. QSD. 1-22(i)-CSK HPKV(Estt.)/- 72559-641 dated 3.11.2022 read with its corrigendum No. 77503-84 dated 28.11.2022. Accordingly, earlier concurrence made in this behalf shall also stands cancelled.
