



**CHAUDHARY SARWAN KUMAR HIMACHAL PRADESH KRISHI
VISHVAVIDYALAYA ENDOWMENT FUND (CSKHPKV ENDOWMENT FUND)**

Chaudhary Sarwan Kumar Himachal Pradesh Krishi Vishvavidyalaya, Palampur is a premier Institute of Himachal Pradesh set up in the year 1978 under an Act of the State Legislative Assembly with the mandate for making provision for imparting education in agriculture and other allied branches of learning. Over the years, the University has contributed enormously in transforming the farm scenario of Himachal Pradesh. It has developed human resources, crop varieties and technologies and transferred these to farming community enabling the State to forge ahead and become self-sufficient on food front.

The Government of Himachal Pradesh and the Indian Council of Agricultural Research, New Delhi are providing the funds to the University for meeting its various financial requirements, however, the finances received from them and other funding agencies are not sufficient to conduct research and to meet the challenges that have emerged in the present era. The issues like climate change and increasing population have necessitated for more intensive research and application of cutting-edge technologies. Further, machine learning and artificial Intelligence (AI) is steadily emerging as part of the Agriculture's technological evolution. Under these circumstances, the University needs to make earnest efforts to raise additional funds.

To meet these objectives, an Endowment Fund to be called "CSKHPKV Endowment Fund" is being created in the University for mobilizing donations, funds and contributions from any employee/retired employee/Alumni of the University, individual, well-wisher, philanthropist, industry as are approved by the Vice Chancellor which will be utilised to achieve the following objectives:

- Granting awards and fellowships to the students.
- Strengthening of facilities and infrastructure in Research, Teaching and Extension Education.
- Reinforcing extension activities for better outreach to stakeholders
- Developing infrastructure to provide better facilities to students, alumni and faculty.
- Mentorship and Placements of students.
- Organizing students' alumni interaction on regular basis.
- Exposure visits to the established enterprise/industrial house set up by alumni and other entrepreneurs.
- Residential facilities for the alumni.
- Engaging foreign experts in academics.
- Any other purpose for betterment of University and students, as decided by Endowment Fund Governing Board

RULES FOR THE OPERATION OF CSKHPKV ENDOWMENT FUND

1. These rules have been framed for the operation of the "Chaudhary Sarwan Kumar Himachal Pradesh Krishi Vishvavidyalaya Endowment Fund" and shall be called "CSKHPKV Endowment Fund Rules, 2024". These rules shall be deemed to have come into force from the date of notification by the University.
2. Chaudhary Sarwan Kumar Himachal Pradesh Krishi Vishvavidyalaya hereinafter referred as University will open a separate bank account for the "CSKHPKV Endowment Fund" where donations from any employee/ retired employee/Alumni of the University/individual/well-wishers/ philanthropists/ industries will be kept.
3. All the money meant for the CSKHPKV Endowment Fund will be received in the separate bank account referred in Rule-2 above and acknowledged by the Comptroller of the University or any other officer designated to do so by the competent authority.
4. The Endowment Fund will be governed by a Board called "CSKHPKV Endowment Fund Governing Board" hereinafter referred as "Governing Board" comprising Vice Chancellor of the University as ex-officio Chairman, Statutory Officers of the University as ex-officio members, three distinguished alumni/donors nominated by the Vice-Chancellor for two years and one representative each from alumni associations, University teaching and non-teaching employee's associations.
5. The Governing Board shall be responsible for the overall management, operation and judicious utilisation of fund for the intended purposes. The meeting of the Board shall be held as and when occasion arises. However, there shall be one annual meeting of the Governing Board in the month of June every year wherein Annual Work Plan/Budget, annual accounts along with annual audited report shall be considered and approved. In any Board meeting, presence of seven (7) members shall constitute quorum provided at least three nominated members from amongst the representatives of alumni associations, University teaching and non-teaching employee's associations are present in the meeting. Any unanimous or majority decision taken in the Governing Board meeting in which quorum is complete shall be deemed to be a decision of the Governing Board.
6. Donations received in the Endowment Fund Account shall be invested in beneficial schemes/deposits/securities as per the recommendations of the Governing Board and earning from them shall be utilised for the intended purposes. However, in the gift

agreement with the donors (or a subsequent understanding with the donor) which allows the use of donation's corpus, the Board may do so for specific activities.

7. The amount of fund shall not be expended in entirety. In the initial stages of implementation, funds not exceeding 40% or as decided by the Governing Board, may only be utilised annually for the intended objectives with a view to maintain a good corpus for the future.
8. Separate and transparent accounting shall be maintained by the University for the CSKHPKV Endowment Fund in the office of the Comptroller of the University. The procedure to incur expenditure out of this fund shall be the same as the procedure prescribed for the expenditure in CSKHPKV Palampur. The charges and expenses incurred for administering the Fund shall be paid from the Fund. The account shall be got audited from the ^{SAP/}CA designated for the purpose by the Governing Board of the CSKHPKV Endowment Fund.
9. The Governing Board of the Endowment Fund may decide to manage the Fund in future through a no profit no loss Trust or Company under Section-8 of the Company Act in view of response received from the donors.
10. Information regarding the CSKHPKV Endowment Fund and its utilization shall be published on the website of the University to keep the stakeholders informed and to attract further funds.
11. The Vice Chancellor of CSK HPKV Palampur will be the competent authority to relax or to amend any rules(s), to interpret these rules and to issue clarification for the smooth operation of the Fund.
