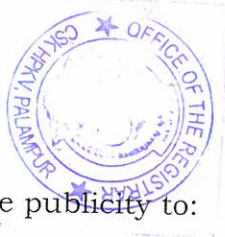

- (ii) Total marks/score obtained in NEET (UG)-2022 for B.V.Sc. & A.H. and total marks/score obtained in ICAR AIEEA (UG)-2022 for B.Sc. (Hons.) Agriculture and B.Tech. (Food Technology) programmes.
- (iii) All India rank/Overall Rank obtained by the candidate in NEET (UG)-2022 and ICAR AIEEA (UG)-2022 (If available);
- (iv) Shall have also to upload score card of respective entrance test (NEET (UG)-2022/ICAR AIEEA (UG)-2022).

The candidates shall have to complete the above process within the stipulated time failing which his/her right for admission to the programme(s) shall stand forfeited and no correspondence in this regard will be made. At this time, no candidate shall be allowed to rectify/add/modify their information/particulars already filled in their online application form.
