OFFICE MEMORANDUM

<u>Subject</u>:- 'Compassionate Employment' - Provision regarding married daughter(s).

- 1. The matter regarding providing compassionate employment/assistance to married daughter(s) in case(s) where the family of the deceased employee has only daughter(s) was under consideration of the Government for some time.
- 2. After due consideration of this issue, it has been decided that married daughter(s) will also be eligible for compassionate appointment, in case the family of the deceased Government employee has only daughter(s) and none in both the families i. e. her parental family and the family into which she is married, are in an employment, funded by the Government. As regards income criteria for married daughter(s), income of the parental family will be taken into account to determine indigency.
- This provision may be brought to the notice of all concerned for information and compliance.
