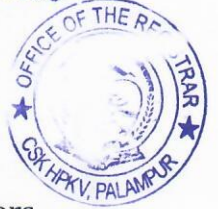



NOTIFICATION

Whereas the State Election Commission has issued election programmes for the conduct of general elections to Municipal Corporation Shimla and by-elections to fill up casual vacancy in Ward No. 2 Palampur Upperla of Municipal Corporation Palampur, Ward No. 9, Dadour of Municipal Council Nerehowk District Mandi, Ward No. 6, Police Thana of Nagar Panchayat Rajgarh District Sirmour and Ward No. 6, PWD Rest House Nagar Panchayat Jawali District Kangra;

Therefore, the State Election Commission in exercise of the powers vested in it under Article 243-ZA of the Constitution of India, Section 9 of the Himachal Pradesh Municipal Corporation Act, 1994 and Section 281 of the Himachal Pradesh Municipal Act, 1994 hereby directs that the Model Code of Conduct as notified by this Commission vide Notification No. SEC-16-29/2000-I-3768 dated 03<sup>rd</sup> November, 2020, shall come into force with immediate effect in the territorial jurisdiction of abovementioned Municipalities till the election process is over.


