OFFICE ORDER

Despite of the instructions issued by this office from time to time with regard to interact, ventilate their views, furnish information about achievements in the fields, pass on various communications and information, give news at their own level to the press and electronic media through the Public Relation Unit of the University and with the due permission of the appropriate authority, it has been observed that some of the employees are still interacting/ communicating directly information to the Press, electronic media/social media or issuing press statement orally or in writing without seeking permission of the competent authority which is sheer violation of rule 11 of the CCS(Conduct) Rules, 1964. The Vice-Chancellor has viewed this practice on the part of the employees of the University very seriously and has ordered that the instructions so issued from time to time in this regard be hence forth adhered to scrupulously.

It is, therefore, once again emphasized that no officer/ official of the University would interact/communicate directly any information to the press and to any other electronic/social media or issue any press statement orally or in writing except through the Public Relation Unit of the University and with the due permission of the appropriate authority. Any violation of Rule 11 as mentioned ibid shall attract disciplinary action under the CCS (CCA) Rules, 1965.

Hence, all the Controlling Officers/ Heads of Departments/Offices/Units should bring it to notice of all the employees working under them for strict compliance and adherence to

the CCS(Conduct) Rules, 1964.
