**CIRCULAR**

Instances have been brought to the notice that some of the employees are bringing political influence in respect of their service matters including transfer/adjustment, Normally transfer/adjustment orders are issued in the interest of University work. The undue pressure given for transfer/adjustment of official will affect the smooth functioning of the University.

As per Rule 20 of CCS (conduct) Rules 1964, no Government servant shall bring or attempt to bring any political or other outside influence to bear upon any superior authority to further his interests in respect of matters pertaining to his service under government. Further, as per Chaudhary Sarwan Kumar Himachal Pradesh Krishi Vishvavidyalaya Statutes, 1988, the provisions of the conduct, discipline inquiry, punishment and appeal in respect of officers, teachers and other employees of the university have been clearly mentioned under Chapter VIII.

Of late, it is noticed that most of the employees are bringing political influence in their favour for one reason or other. This act is in violation of the aforesaid provisions of CCS(Conduct) Rules/ Statutes, 1988 clause 8.1(13) and such employees are liable for disciplinary action in accordance with provisions of CCS (CCA) Rules, 1965. **It is, therefore, emphasized that no officer/ official of the University to indulge in such kind of activities.**

Hence, all the Controlling Officers/ Heads of Departments/Offices/Units are requested to bring it to notice of all the employees working under them for strict compliance and adherence to the CCS(Conduct) Rules, 1964 and provisions under chapter-VIII of Statutes, 1988 failing which disciplinary action shall be taken initiated under the CCS(CCA) Rules, 1965 for the violation of the Rule mentioned ibid.
