**NOTIFICATION**

The Governor, Himachal Pradesh is pleased to declare 05<sup>th</sup> November, 2023 (Sunday) as a "Paid Holiday" (in case poll is held) in the area of Municipal Council Ward No. 02 Miyanpur of Nagar Panchayat Arki District Solan and Ward No. 06 Chhawanivir Hospital Nagar Panchayat Chopal District Shimla, Himachal Pradesh, where bye-election is scheduled to be held to fill up the vacant seat in the above mentioned Municipal Council. **This will also be a paid holiday to daily wages employees and also within the meaning of Section 25 of Negotiable Instrument Act 1881.**

All Government Offices, Boards, Corporations, Educational Institutions, Banks, Post Office and Industrial Establishments situated in the Himachal Pradesh under Industrial Disputes Act and shops in the area mention above will remain closed on the said date in the mentioned area.

It is, however, clarified that special casual leave may be given to those employees who are working in different places in the State but have a right to vote in concerned institutions (where the By Election of PRIs are scheduled to be held) on the production of certificate from the concerned Presiding Officer that the employee has actually cast his/ her vote.


