1.	Retainership Fee.	Rs. 7500/- per month.
2.	Fee for contesting/defending the cases instituted against the University till finalization of the case in the Court of law.	Rs.6000/- per case (Including clerical charges)
3.	Fee for initiating cases by the University till finalization of the case in the Court of Law.	Rs.7000/- per case (50% to be paid after institution of the case and balance 50% on finalization of the case). (Including clerical charges)
4.	Expenses on account of purchase of stamp papers, judicial papers and stamps, attestation charges for affidavit charges, etc. if any and fee paid for obtaining copies of court orders/judgment.	As per actual expenses.
5.	No payment shall be payable for drafting of Reply/Appeal/Caveat/ Miscellaneous applications etc. and for rendering advice/legal opinion.	

The Vice-Chancellor has further been pleased to allow the former Standing Counsels to defend the cases pending for decision of their tenure as Standing Counsel in the Hon'ble High Court of Himachal Pradesh, Shimla on the terms and conditions mentioned during their appointment.
