The Academic Council vide resolution No. 32 of its 204th emergent meeting held on 28.06.2024 has approved the following terms and conditions for imparting RAWE Programme to the outside students of recognized University by CSKHPKV, Palampur:

- 1. The nominating institute will put a request to the CSKHPKV, Palampur pertaining to nomination of students to undergo RAWE training at CSKHPKV, Palampur.
- 2. The nominating institute must appoint a Nodal Officer with whom all the correspondence related to RAWE programme can be made from time to time.
- The allotment of station/KVK and slot will be done after getting official nomination from the
 concerned College/Institute/University of the students to undergo RAWE training
 programme subject to the availability of the lodging facilities at the respective stations/ KVKs
 during the particular slot.
- 4. The consultancy charges for RAWE programme will be Rs. 5000/- per month/per student.
- 5. Boarding/lodging charges will be borne by the concerned student/institute.
- 6. The lodging charges will be charged from the student/institute as per university norms.
- 7. Transportation charges i.e. movement of student will be borne by the concerned student/institute at their own and fare/ expenditure in this account will be borne by the concerned student/institute.
- 8. The students are required to adhere to discipline in all respects and CSKHPKV, Palampur reserves the right to debar the students from the RAWE programme at any stage if found to be indulged in any unfair means, omission and misconduct of behavior.
- The undertaking will be given by the respective host institute regarding that nominated students will abide by the terms and conditions of CSKHPKV, Palampur.
- 10. The students must adhere to any other terms and conditions if applicable, as per University rules with the approval of competent authority.
