It is for information to all concerned that CSK Himachal Pradesh Krishi Vishvavidyalaya, Palampur has framed the following rules and Guidelines for Migration of students of B.V.Sc. & A.H. degree programme from other college to B.V.Sc. & A.H. programme of CSKHPKV, Palampur for the Academic year 2024-25 as under:

1. VCI regulation for the migration as per MSVF-2016 adopted by the CSKHPKV, Palampur are as under:

Migration or Transfer of Student :-

- i. Student studying in a recognized Veterinary college which is included in the First Schedule of the Act may be allowed to migrate or be transferred to another recognized Veterinary college under another or same University.
- The migration or transfer may be allowed by the university concerned after passing 1st year of ii. Bachelor of Veterinary Science and Animal Husbandry degree course within one month of the start of Academic session of 2nd year of the receiving College or University.
- The number of students migrating or transferring from one Veterinary college to another iii. Veterinary college during the period of one academic year will be kept to the maximum limit of 5% of the intake capacity of each of the Veterinary colleges in one year.
- 2. Total number of seat available for migration students will be **Four** (5% of intake capacity of 75 seats). In case of more than four applications for migration, the admission will be done strictly on merit basis as per university rules.
- 3. Application complete in all respect must reach to the Registrar, CSKHPKV, Palampur by 30th Sep. 2024. The University will not be responsible for any postal or other delay. Application must have following documents attached otherwise will not be considered for migration:
 - Application fee of Rs. 15,000/- in the shape of Demand Draft in favour of Comptroller, CSKHPKV, Palampur for processing of application.
 - No objection certificate from the Registrar of present Institute of the applicant, with the clear mention of the category (General, Self- Financing/ Paid, etc.) in which he/ she got admitted there.
 - iii. Marks sheet of First Professional Year passed by the applicant.
- 4. The list of selected candidates will be notified on 3rd Oct. 2024. The candidate of Self-Financing/ Paid seat category will be considered in SFS category of admission for all the purposes.

5. The selected candidates shall have to register by 05.10.2024 by 04.00 PM and deposit the requisite fee.
