IMPORTANT INSTRUCTIONS TO THE CANDIDATES

1. It is mandatory for all the candidates as per Annexure(s) to report in person for Counseling-cum-Registration & Admission-I to above said programmes to the Dean, Postgraduate Studies, CSKHPKV, Palampur for M.Sc. Agriculture on 11.11.2024 by 11.30 AM and for M.Sc. Basic Sciences & M.Sc. Community Science on 12.11.2024 by 11.30 AM and mark his/her attendance in the attendance sheet/register kept for the purpose, otherwise his/her candidature shall not be entertained and his/her right to admission shall be forfeited. The candidature of the candidates reporting after 11.30 AM shall not be considered/ entertained. The candidate(s) who finds himself/herself selected through Counseling-cum-Registration & Admission-I process, shall have to deposit the requisite fee and get himself/herself registered by 4.00 PM on the same day failing which his/her claim for said seat shall be forfeited and he/she shall have no right for his/her admission from the waiting list to be issued by University. However, such candidates can participate/take part in the final round of Counseling/Mop-up round for admission to the respective programme(s).




2. It is also for information to the candidates that the order of preference for admission in different disciplines of Masters in Agriculture shall be as under:
 - i) 1st Preference: B.Sc. (Hons.) Agriculture/B.Sc. Agriculture
 - ii) 2nd Preference: B.Sc. (Hons.) {Horticulture/Forestry/Sericulture}/B.Sc. {Horticulture/Forestry/Sericulture}Accordingly, the admissions to M.Sc. Agriculture programme will be made through Counseling-cum-Registration & Admission-I by the Counseling-cum-Registration & Admission Committee.
3. Where two or more candidates have obtained equal marks in the respective entrance test, their merit will be decided on the basis of rank in the respective entrance test as declared by NTA/ICAR for admission to the respective programme. In the eventually of same rank or where rank not awarded the merit will be decided on the basis of performance in the qualifying examination. If still there is a tie, then the candidate older in age will be considered higher in the merit. Accordingly, the final select /waiting list of the candidates who have obtained equal marks in the ICAR AIEEA (PG)-2024 is purely tentative. The merit of the candidates in such cases for admission will be decided at the time of respective Counseling-cum-Registration & Admission-I, as the case may be and the candidate(s) higher in merit as per mode of admission will be admitted after scrutinizing his original certificates/documents including rank card of ICAR AIEEA (PG)-2024 relating to admission on the spot by the Counseling-cum-Registration & Admission committee.
4. Admissions under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25 and hence the list under Sports/Co-curricular activities is tentative.
5. For the process of verification of documents, the candidates shall have to show Admit Card of respective Entrance Test alongwith all the original certificates/documents relating to admission to the Counseling-cum-Registration & Admission Committee at the time of Counseling-cum-Registration & Admission-I and also submit the counseling proforma at Annexure-IX duly filled in all respects, to be downloaded from the University website alongwith two copies of recent his/her photograph alongwith two sets of self-attested photocopies of the certificates/document relating to admission, at the time of document verification, failing which the candidate shall have no right for admission to the programme.
6. The candidates on confirmation of admission to a seat through Counseling-cum-Registration & Admission-I shall have to pay fees and other charges except hostel charges on the same day at the time of Counseling-cum-Registration & Admission-I in the office of the Dean, Postgraduate Studies, CSKHPKV, Palampur upto 4.00 PM in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC : SBIN0003632) at SBI, HPAU, Palampur or Account No.99930000001978 (IFSC : HDFC0001736) at HDFC Bank, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day in the office of the Dean, Postgraduate Studies, CSKHPKV, Palampur to complete the admission process on the same day otherwise the seat will be declared vacant and his/her right for admission shall stand cancelled and he/she will not be eligible for admission. Also, if any candidate remains absent at the time of document verification, fee deposition, the seat will be presumed to be vacant. Further, if a candidate refuses to accept admission at his/her own turn, he/she shall lose his/her right for admission to the programme. However, such candidates can appear in the final round of counseling/mop-up rounds of the programme.

7. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure IV as per medical and physical fitness standards prescribed in Annexure V of the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25 at the time of Counseling-cum-Registration & Admisson.
8. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25.
9. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority at the time of counseling failing which they shall have no right for admission to EWSs category of Masters' programme.
10. If a candidate fails to attend the Counseling for M.Sc. Agriculture on 11.11.2024 by 11.30 AM and for M.Sc. Basic Sciences & M.Sc. Community Science on 12.11.2024 by 11.30 AM as per mode of admission, his/her candidature will be cancelled.
11. The admission to Masters' programme shall be made as per the provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25 of the University.
12. While every care has been taken in preparing the final provisional select/waiting lists for Counseling-cum-Registration & Admission-I to above said programmes, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.


