


LUCACIONI AND ACCOMMINGUACIONS

The training program will take place at or near MATC - MASHAV's International Agricultural Training Center in Kibbutz Shefayim, situated 20 km north of Tel Aviv and near the coastal city of Netanya (Specific hotel to be confirmed). Participants will be accommodated in double rooms (2 participants per room) on FB basis.

MASHAV awards a limited number of scholarships. The scholarship covers the cost of the training program including lectures and field visits, full board accommodation in double rooms, health insurance and transfers to and from the airport. Airfares and daily allowance are not included in the scholarship.

#### **Application Requirements**

The program is geared towards senior policy makers, officials and professionals from governmental and non-governmental institutions, directly involved in agricultural and rural resilience and food security development programs on a national, regional or local level. #### **General Health Services:**

- MASHAV'S Medical declaration must be completed and submitted to the Embassy of Israel together with the application form.
- Participants will be covered by a medical insurance contracted by MASHAV. The medical insurance coverage applies only for the duration of the training, and does not include additional days, in cases of early arrivals or late departures.

MASHAV'S medical insurance covers only medical services and hospitalization in case of emergency. It does not cover the treatment of chronic or existing conditions, specific medications taken by the participant on a regular basis, dental care and eyeglasses. Participants will be responsible for all other expenses, which are not covered by the insurance policy. Israeli Health authorities recommend that all visitors to Israel make sure they have been vaccinated against tetanus in the last ten years.

#### Background

The traditional farming system of India prior to the 20th century was generally organic or natural with low production potential. Chemo-centric technological advancement during Green Revolution period boosted the production potential and provided food security to the nation. However, over a period of time, this production system has started exhibiting its carrying capacity as reflected by production plateau in green revolution belt. The success of industrial agriculture and the green revolution in recent decades has often masked significant externalities, especially sustainability of natural resources such as deterioration of soil health, depletion of groundwater, depletion of bio diversity, degradation of ecology and environment, poor nutrition and less farm income due to high input cost, etc. Increasing consciousness about conservation of environment as well as health hazards associated with agrochemicals and consumers' preference to safe and hazard-free food are the major factors that lead to the growing interest in alternate forms of agriculture in the world.

Organic and natural farming are among the broad spectrum of production systems that are supportive to the environment. These farming systems are non-chemical farming systems that promote biodiversity and sustainable development. However, they differ in their approach to soil, fertilizers, and other practices. Natural farming (NF) is a traditional, chemical-free farming rooted in Indian tradition enriched with modern understanding of ecology, resource recycling and on-farm resource optimization. It doesn't use external fertilizers or plowing, and instead encourages the decomposition of organic matter by microbes and earthworms. This method is based on biomass mulching, green cover, and indigenous cow-based dung and urine formulations. It is often cost-effective and requires fewer external inputs, whereas organic farming (OF) uses organic fertilizers and manures like compost, vermicompost, and cow dung manure. It also requires basic agro practices like plowing, tilting, mixing of manures, and weeding. It can be expensive because of the need for bulk manures, and it can have an ecological impact on the surrounding environment. The Government of India recently approved the launching of the National Mission on Natural Farming (NMNF) to promote natural farming across the country. The NMNF is a standalone centrally sponsored scheme under the ministry of agriculture & farmers' welfare. It has a total outlay of Rs. 2,481 crore. In the next two years, the government plans to implement NMNF in 15,000 clusters in gram panchayats, which are willing, and reach one crore farmers and initiate natural farming (NF) in 7.5 lakh ha area.

In India, efforts to develop, refine and disseminate organic farming technologies have been underway for nearly three decades and made significant progress even though there are several constraints that affect adoption, whereas in case of natural

farming, there is an urgent need to understand biological systems and the natural processes h and to refine the existing knowledge of the pract that the farmers have the space and power decision based on their local contexts. 

#### Background

Soil is an indispensable natural resource that underpins terrestrial ecosystems and serves as the cornerstone of agriculture, forestry, and environmental sustainability. In contrast, modern soil resource mapping employs advanced geospatial techniques, providing precise and efficient tools for understanding soil properties, their spatial distribution, and overall condition. These insights enable informed decision-making and sustainable land use planning.

In recent decades, geospatial technologies have transformed soil resource management. Tools such as remote sensing (RS), geographic information systems (GIS), and digital soil mapping (DSM) utilize spatial data to tackle the complexities of soil resource management. These technologies facilitate detailed analyses of soil properties, modeling of soil processes, and the development of strategies for sustainable land management. Additionally, they address critical global challenges, including soil degradation, erosion, and nutrient depletion, while supporting precision agriculture, land restoration, and climate change adaptation. Despite challenges such as limited data accessibility and the demand for skilled expertise, advancements in geospatial technologies hold immense potential. They provide innovative solutions for enhancing soil health and ensuring the sustainable utilization of this vital resource, thereby contributing to global food security and environmental sustainability.

To build capacity in these transformative geospatial techniques, ICAR-National Bureau of Soil Survey and Land Use Planning (NBSS&LUP), Nagpur, is actively engaged in creating soil-based thematic databases and maps through field surveys, soil analysis, cartography, and the integration of remote sensing, GPS, and GIS.
