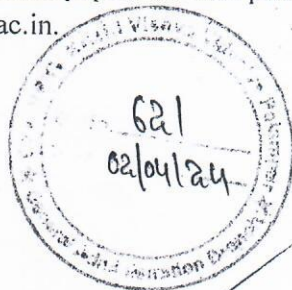

As you all know that the financial year 2023-2024 has ended/closed and the funding agencies of different ICAR/Adhoc Projects release the funds for the next year only after the receipt of Audited Grant Utilization Certificate (AUC) of the previous year. The delay in the submission of AUC will not only affect the working of the project concerned but also create many other financial management problems. It is therefore, desirable that the AUC for the preceding financial year i.e. 2023-2024 be submitted to the concerned funding agency well in time so that the funding agencies will release the funds for the execution of project activities during the current financial year 2024-2025.

You are, therefore, requested to get the expenditure reconciled in the Compilation Branch and ensure that the Audited Grant Utilization Certificate along with head-wise expenditure statement for the year 2023-2024 in respect of AICRP projects, KVKs and other Adhoc Projects may be submitted to this office by 20th April 2024 positively. In case the AUC is/are not submitted to the funding agency in time, it may not be possible for this office to release the payments/salary of the concerned project staff and this office will not be responsible for any delay in receipt of funds.
