The Selection Committee invites applications for the position of Vice Chancellor, Chaudhary Sarwan Kumar Himachal Pradesh Krishi Vishvavidyalaya, Palampur, District Kangra (H.P.) as per the Act & Statutes of the Himachal Pradesh Universities of Agriculture, Horticulture and Forestry Act, 1986. The following specific criteria have been included by the Selection Committee for assessing the suitability of the prospective candidates for the post of Vice-Chancellor of the above said university:-

Essential

1. Experience in the field of Higher Agriculture Education as Professor or equivalent at least ten years in teaching, research extension in a University (State Agricultural University, Deemed University, Central Agriculture University, Central University or equivalent) or well established institution of repute at the National/International level.
2. Administrative experience in the field of Higher Agriculture Education not below the rank of Professor and Head of the Department in a University (State Agricultural University, Deemed University, Central Agriculture University, Central University or equivalent) at least for 5 years or Dean/Director (in Professor's grade) of University at least for 3 years or Director of National/International Institution of Advanced Learning at least for 3 years.
3. Experience of working in at least one of the statutory Authority/forums of a university such as Board of Studies, Academic Council, Management Council or Executive Council, Board of Management, Senate etc.
4. He/She should have published at least 10 research papers, out of which at least 05 should be in Journals with equal or more than 07 (Seven) NAAS ratings.

Desirable

5. Execution experience in major research and development projects in Agricultural field.
6. Should have experience of working with international bodies or international exposure through participation in workshops, seminars or conferences held outside the country.
7. Experience of organizing events such as workshops, seminars, conference at an international level within the country in the field of higher education.
8. Should be recognized with fellowship of professional societies/academies, awards and honours reflecting his/her eminence in agricultural research/education/extension.

The Vice-Chancellor shall normally hold office for a term of three years and be eligible for reappointment for another three years but not beyond the age of 65 years.

The applicant should also be able to give an undertaking that he/she will be able to take up the assignment immediately.

Applicant has to give an undertaking that no Departmental Enquiry/Criminal case is pending against him/her.
