With reference to the subject cited, I am directed to convey that the Hon'ble Commission has decided to give away the following Awards for year 2024:-

#### A. Best Electoral Practice Awards.

- (I) **General Category Award** will be presented to the best performing District Election Officers (DEOs)/ Superintendents of Police (SPs) in the area of election management. The award would carry a plaque and a citation. The nominations for the award will be in the following indicated field of election management:
  - Election Management
  - Voter's Education and Electoral Participation
  - IT Initiatives
  - Security Management
  - Electoral Roll Management
  - Innovative Measures
  - Accessible Elections
  - Electoral Literacy Clubs
- (II) **Special Award** will be presented to officers, other than DEOs/ SPs for the best practices in the area of election management. The award would carry a plaque and a citation. The nominations for the award will be in the indicated field of election management as stated above for the General Category Awards. CEOs may nominate officers from among all officers/staff engaged in election management (including those from CEOs office).
- (III) Best Performing State Award will be given to a State displaying best overall performance in the areas of election management. The nominations for the award will be in the indicated field of election management as stated above for the General Category Awards. The Award would carry a plaque and a citation, and it would be received by the Chief Electoral Officer of the State/UT.

- B. Civil Society Organisation (CSO) Award for the best campaign on Voter Education and Awareness. Award will be given to institutions, organizations or individuals for promoting electoral participation through effective and innovative programmes or projects. The award would carry a plaque and a citation. The details of the scheme and criteria of the Award is enclosed at Annexure 'A'.
- C. Award to Govt. Department/Agency/PSU for enhancing Electoral Participation. This Award will be given to Govt. Department/Agency/PSU for promoting electoral participation, including accessible elections. The Award would carry a plaque and a citation. The scheme and criteria of the Award is enclosed at Annexure 'B'.
- D. Annual State Awards for Best Electoral Practices. Annual State Awards for Best Electoral Practices was instituted in 2014 to recognize the efforts and contribution of the Officers and the staff engaged in elections, and to commend and encourage individual and team accomplishments in diverse fields of election management. These awards will be given in the States. The guidelines and framework for this category is enclosed at Annexure 'C'.
- 2. Nominations: The achievements/significant contributions for the said awards of all categories should be of the period since the last date of nomination for Best Electoral Practices Award, 2023 (i.e. 10.12.2023). The CEOs shall send the nominations for Awards, with their recommendations, in the enclosed format (Annexure D) along with the requisite enclosures, possibly in spiral binding form in duplicate. All the nominations shall have the signature of concerned CEOs. For CSO Award and Award to Govt. Deptt./Agency/PSU, CEOs may ensure that the entries are in prescribed format and duly recommended by the Chief Electoral Officer. The restriction with regard to the number of nominations sent from State/UT, may strictly be adhered to. The States/UTs can send the following number of Nominations:-

  - (ii) Increase in Gender ratio on rolls
  - (iii) Increase in 18-19 years registration
  - (iv) Increase in reg stration of PwD, NRI, excluded class, etc.
  - (v) EPIC/PER Coverage, EPIC distributed in NVD
  - (vi) Partnership building
  - (vii) Conduct of Elections-peaceful and incident free polls
  - (viii) Voter turnout -Overall and in low turnout and vulnerable PS
  - (ix) Voter Turnout meeting gaps in gender, urban and youth participation
  - (x) Innovation in process / procedure
  - (xi) Innovation in the use of technology
  - (xii) Accessible Elections
  - (xiii) Electoral Literacy Clubs
  - (xiv) Additional indicators (may be stated)
- 3.3 The procedure to select the winners for the Annual State Awards will be done by the concerned CEO as per the guidelines and framework enclosed at Annexure 'C'.

- 4. Last Date: The nominations in the prescribed format, for the Best Electoral Practices Awards, CSO Award and Award to Govt. Department/Agency may be sent to the Commission latest by 21<sup>st</sup> October, 2024. For the Annual State awards, the names of the selected winners to be sent to the Commission, for its approval, latest by 30<sup>th</sup> November, 2024.
- 5. The Awards shall be given on National Voters' Day, those at Para 1'A', 'B', &'C' at the National function of NVD, 2025 in New Delhi and those at Para 1'D' at the State function of NVD.

# State/UT Awards for Best Electoral Practices

(Framework)

Annual State awards for Best Electoral Practices shall be instituted by all States/UTs from 2014 to recognize the efforts and contribution of the Officers and the Staff engagement in elections, to encourage and recognise individual and team accomplishments in diverse fields of election management. The broad framework of the awards is as follows:

- 1.1 The Awards shall be presented to the outstanding performing District Election Officers (DEOs) (other than National Award winners), ERO/AERO and BLO of the State. The awards may carry a cash component. The awards would be given to the officials who have done exceptional innovative work in election management.
- 1.2 **Special Award** will be presented to officers who have made significant contribution to conduct of elections, covering all areas like SVEEP, Expenditure control, Technology, Security, Polling Station management etc. from amongst all officers/staff of all categories outside those mentioned at 1.1. This award may also carry a cash component.
- 1.3 The Officers winning the Best Electoral Practices Award at National level may not be given the State Award. However the Best Electoral Practices Award winners from the state shall be mentioned at the State level function (NVD) though they are not given any award at the State level NVD function (the names of Best Electoral Practices Award winners shall be intimated before 30<sup>th</sup> December).

#### 4. OTHER AWARDS

The State may also institute Awards to recognize the contribution from Campus Ambassadors, Village Awareness Groups (formed under directions from EEM), Civil Society and Media for their contribution to the electoral process. These Awards may be instituted on need basis and wherever the contribution from this category of partners have been worthy of recognition and acknowledgement.

#### 5. SELECTION

- 5.1. A Committee at State/UT Level may be constituted to scrutinize the nominations and shortlist the winners. The constitution of the Committee may be sent to the Commission for approval.
- 5.2. All officers nominated by the CEO for the Best Electoral Practices Award may automatically be included for the State Award for consideration of the State Committee. In addition, more entries may be invited.
- 5.3. DEOs may submit their nominations to the CEO for Best DEO Awards.
- 5.4. The nominations for remaining Awards, including those instituted under Serial No '4' may be forwarded by DEOs to the CEO.
- 5.5. The selected names shall be recommended to the Commission for approval.
- 5.6. The awards shall be given away on National Voters Day at State/UT HQs.
- 5.7. Detailed guidelines on the selection and nomination may be chalked out by the CEO within this broad framework and communicated to the Commission.

### 6. FUNDING

The funds for the Award for 2024 shall be met from the State funds (under Elections/ER) and no separate budget shall be provided by ECI for the same.
