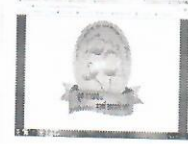



2. Security Officer


