**OFFICE ORDER**

In pursuance of the office memorandum No. Fin(C)-B(7)-13/2009 dated 10.11.2023, No. Fin(C)A(3)-5/2004 dated 24.07.2024, letter No. Fin(C)A(7)-13/2009 dated 09.08.2024 and letter No. Fin(C)-B(7)-13/2009 dated 07.10.2024 issued by the Principal Secretary (Finance) to the Govt. of H.P. regarding re-engagement/hiring of retirees in the Departments duly adopted as such in the University vide notification No. QSD. 2-9/CSKHPKV(GA)/- 63398-497 dated 30.12.2024 and further the decision of the Finance Committee taken vide item No.130(33) of its 130<sup>th</sup> meeting held on 25.11.2024 duly approved by the Board of Management (through circulation) in its 129<sup>th</sup> meeting, the Vice-Chancellor has been pleased to re-employ/re-engage the services of **Sh. Virender Singh, Radiographer (retired)** as "**Office Assistant**" in the Department of Vety. Surgery & Radiology, DGCN, COVAS, CSKHPKV, Palampur for a period of one year with immediate effect i.e. from the date of issue of this office order in the public interest. The terms and conditions of his re-employment shall be as under:-

- i) The tenure of engagement shall be for a period of one year or till the appointment of regular incumbent whichever is earlier.
- ii) He can be terminated before the expiry of specified period in case conduct and performance of the incumbent are not found satisfactory by giving 15 days notice.
- iii) He shall draw fixed monthly emoluments @ Rs. 40% of the basic pay last drawn by him. No Dearness allowance or any other allowance will be admissible on this fixed amount.
- iv) He shall be entitled for TA/DA as is admissible to an outsourced person, if any.
- v) He shall be entitled to leave as is admissible to an outsourced person, if any.
- vi) No medical facility will be given to the incumbent.
- vii) He may be allowed to retain the allotted University residential accommodation, if in continuous possession at the time of such engagement.
- viii) The period of the employment does not qualify as service for pension and other benefits, if any.
- ix) All the expenditure will be met out of Self Finance Scheme (SFS) of the Dean, DGCN COVAS, CSK HPKV, Palampur.

- x) He is required to submit a self-declaration form at the time of joining on such re-engagement.
- xi) He will perform the duty of Radiographer as was being performed by him before his retirement.
