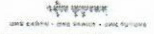



NOTIFICATION

Whereas, the Government of Himachal Pradesh is making all endeavours to achieve the targets/objectives of "Digital India Land Records Modernization Program" and has achieved substantive progress in Digitization of land records.

Whereas, the Government intends to improve the public service and governance with regards to services related to Land records, registration and issuance of various certificates etc. and accordingly authenticate the related data with Aadhaar number of the stakeholders..

Whereas section 4(4) (b) (ii) of the Central Aadhaar (Targeted delivery of Financial and other Subsidies, Benefits and Services) Act, 2016 therein after refer to as "the said Act"), allows performing authentication on voluntary basis, for such purpose, as the Central Government in consultation with the Authority, and in the interest, may prescribe.

Whereas for such purpose Government of India has framed the Aadhaar Authentication for Good Governance (Social Welfare, Innovation Knowledge) Rule, 2020 wherein the State Government can seek permission under the said rules to use Aadhaar on Voluntary basis.

Whereas Government of India vide letter No. 13(4)/2020-EG-II (Vol-XII) dated 7th March, 2024 has conveyed the approval of the competent authority to allow seeding of Aadhaar and authentication of citizens during seeding of Aadhaar with Land Records, issuance of different certificates such as Bonafide, SC, ST, OBC, Income, Legal Heirs, Minority, Dogra Class, indigent, Unemployment, Character, Rural/Backward Area, Agriculture, Freedom fighters, Domicile, EWS, Land Holding and Registration of documents like Sale, Gift, Settlement, Mortgage Exchange, Further change, Power of Attorney, Will, Affidavit Partition, Release, Adoption, Bond lease Divorce, Partnership, Transfer, Warrant, Trust instruments, Using Yes/No or/and e-KYC authentication facility.



Now, therefore, in pursuance to the approval accorded by the Ministry of Electronics and Information Technology (MeitY), Government of India, it is hereby notified that Aadhaar seeding and authentication on voluntary basis may be done by the H.P. Department of Revenue for the purpose of identification as per rule 5 of the Aadhaar Authentication for Good Governance (Social Welfare, Innovation Knowledge) Rule, 2020.

The Director, Land Records cum Inspector General of Registration shall separately issue detailed guidelines regarding methods of identification in case the claimants do not intend to authenticate using his Aadhaar.

The consent form to be collected from the claimants is specified in schedule "A".

SCHEDULE "A"

Consent Form

I-----Holder of Aadhaar No.-----give my consent to Government of Himachal Pradesh for fetching my identify and other information for purpose of e-KYC through UIDAI, using the Aadhaar OTP or Biometric authentication-with UIDAI and seeding it with Record of Rights and at the time of Registration of deeds and schemes & services provided by Revenue department, Government of Himachal. I also give my consent for using my Aadhaar Number for disbursement of benefits through DBT for the Government Welfare Scheme notified under section 7 of Aadhaar Act.


The consent and purpose of collecting Aadhaar has been explained to me in local language. The department has informed me that my Aadhaar shall not be used for any purpose other than mentioned above.

I have been given other alternative means by the department for KYC purposes including physical KYC by submitting officially valid documents and I Have voluntarily chosen Aadhaar based KYC.

I understand that the Biometrics and/or OTP I provide for authentication shall be used only for authenticating my identify through the Aadhaar Authentication system for that specific transaction and for no other purposes.

Consent for using personal data

I-----Holder of Aadhaar No.-----hereby give my consent to use my personal data available with various departments of State and Central for creating the family database of government of Himachal. I am aware that this database shall be used for deciding my eligibility for various schemes, service and projects of the Government.
