




Sir,

Secretary power to the GoHP has requested Hon'ble HPERC to issue following directions/order to HPSEBL vide letter No. MPP-C(010)-5/2021-11 Govt. of HP Deptt. of MPP & Power dated 31.12.2024 in the matter of subsidy under Domestic Supply shall not be available for consumption of electricity w.e.f 01.01.2025 for which bills are to be issued in February, 2025.

- (i) Group-A and Group-B employees/pensioners of Govt. of HP as classified vide Department of Personnel letter No. PER(AP)-C-Λ(3)- 5/2023-II dated 22.11.2022 (formerly categorized as Class-I and Class-II employees).
- (ii) Group-A and Group-B employees/pensioners of the Central Govt. Boards, Corporation, Universities of State/Central Govt. Undertakings, State/Central Govt. PSUs employees working/residing in the State of Himachal Pradesh in corresponding pay scales/pay matrix as mentioned in the letter dated 22.11.2022.
- (iii) This shall also be applicable to same class of employees/pensioners of Military and Para-Military Forces working/residing in the State of Himachal Pradesh.


In this context, it is to intimate that till date we have not received the direction/order from HPERC on the withdrawal of subsidy. However, the necessary change in the billing system may be made so as to implement the subsidy withdrawal to above mentioned class of consumers.
