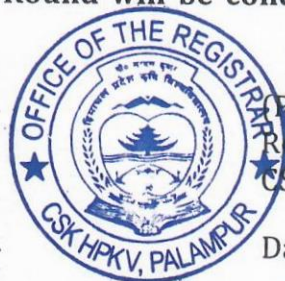

2. The candidates wishing to take admission through Last Round of Counseling/Mop-up Round will have to appear for the same on the above specified date and time of Last Round of Counseling/Mop-up Round at the venue of counseling as indicated above for the respective programme.
3. The candidates shall have to mark their attendance in the attendance sheet/register kept for the purpose in the Office of the concerned Dean on the above specified dates upto specified time of Last Round of Counseling/ Mop-up Round of the respective programme.
4. The admissions through Last Round of Counseling/ Mop-up Round will be made as per provisions contained in Information Brochure & Prospectus Merit Based Admissions 2020-21 and subsequent notifications issued by the University.
5. The candidates who had applied earlier for the above degree programmes need not to apply again but have to appear for Last Round of Counseling/ Mop-up Round. If any such candidate has not applied earlier under SFS category, he/she can apply for the same by depositing the requisite fee on the spot within specified time on the day of Last Round of Counseling/ Mop-up Round. Further, if a candidate who had not earlier mentioned his/her category or failed to produce the desired certificate, he/she can also apply under the said category by producing the respective certificate.
6. All eligible candidates who did not apply for admission earlier can do so by applying with requisite fee on the spot within above specified time on the day of Last Round of Counseling/ Mop-up Round.
7. The candidates shall have to bring all the original certificates/documents relating to admission with a set of self attested copies of all the relevant documents as mentioned in the counseling proforma alongwith counseling proforma (to be downloaded from the University website <http://hillagric.ac.in>) duly filled in all respects for admission through Last Round of Counseling/ Mop-up Round.
8. The admission shall be made on the basis of merit list (as per mode of admission) to be drawn on the day of Last Round of Counseling/ Mop-up Round.

The candidates appearing in Last Round of Counseling/ Mop-up round in case they are offered a seat for admission, must have to deposit requisite amount of fee except hostel charges in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC : SBIN0003632) at SBI, HPAU, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day.
10. If a candidate fails to register as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
11. The vacancy position indicated above may vary and also arise of any category at the time of Last Round of Counseling/Mop-Up Round for filling up.
