If the seats in any category {except the categories Wards of Kashmiri Migrant and Kashmiri Pandits/Kashmiri Hindu Families (Non-Migrants), In-service Nominee of CSKHPKV, Palampur, Fellowship Awardee} due to non availability of eligible candidates, will be added to general category at the time of Final Round of Counseling/Mop-up Round on the spot and shall be filled up, accordingly.

Note:

1. **No separate communication will be made.**
2. **All the candidates who appeared in ICAR AIEEA (PG)-2022 and filled the online application form of this University with requisite fee for admission to M.Sc. Community Science programme of this University will only be entitled to appear in Final Round of Counseling/Mop-up Round for admission to M.Sc. Community Science programme of the University.**
3. **The admission of the candidate will be considered in the same discipline(s) of Master's programme of this University i.e. in the sub-subjects of Major Subject Group of ICAR AIEEA (PG)-2022 in which he appeared in ICAR AIEEA (PG)-2022**
4. **The eligible candidates wishing to take admission through Final Round of Counseling/Mop-up Round will have to appear on the above specified date and at the respective venue mentioned above upto 11.00 AM for counseling.**
5. **The candidates shall have to mark their attendance in the attendance sheet/ register kept at the venue of counseling for the purpose positively by 11.00 AM.**
6. **The admissions through Final Round of Counseling/Mop-up Round shall be made as per provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23 and subsequent notifications issued by the University.**
7. **The candidature of the candidate to the programme will only be considered against the specific category for admission as he/she has applied for the said category at the time of filling online application form.**
8. **If a candidate has not opted for Self-Financing seat at the time of filling online application form, his/her candidature for Self Financing seat shall not be considered in Final Round of Counseling/Mop-up Round.**
9. **In case of non-availability of HP Bonafide candidates, the candidature of Non-H.P. Bonafide candidates can be considered against the vacant seat(s) of H.P. Bonafide category, if any, at the time of Final Round of Counseling/Mop-up Round. In such cases, the candidates shall have to attend the Final Round of Counseling/Mop-up Round.**
10. **Where two or more candidates obtain equal marks in the respective entrance test, their merit will be decided on the basis of rank in the respective entrance tests as declared by NTA/ICAR for admission to the respective programme. In the eventuality of same rank, the merit would be decided on the basis of percentage of aggregate marks obtained in the concerned subjects of the qualifying examination. If there is still a tie, then the candidate older in age will be considered higher in the merit.**
11. **The candidates shall have to show all original certificates/documents relating to admission alongwith NTA/ICAR score card and rank card to the Counseling-cum-Admission Committee of the University at the time of Final Round of Counseling/Mop-up Round. Simultaneously, the candidate shall have also to submit two copies of his/her recent photograph and two sets of self-attested copies of all the relevant certificates/documents (as mentioned in the Counseling Proforma) relating to admission alongwith counseling proforma at Annexure IX of the Information Brochure and Prospectus Entrance Test Based Admissions 2022-23 (to be downloaded from the University Website <http://hillagric.ac.in>) duly filled in all respects, at the time of document verification to the Counseling-cum-Admission Committee for admission through Final Round of Counseling/Mop-up Round to M.Sc. Community Science programme.**

12. The admission shall be made on the basis of merit list as per mode of admission to be drawn on the day of Final Round of Counseling/Mop-up Round.
13. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure IV as per medical and physical fitness standards prescribed in Annexure V of the Information Brochure & Prospectus Entrance Test Based Admissions-2022-23 at the time of Final Round of Counseling/Mop-up Round.
14. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23 and subsequent notifications issued by the University.
15. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset Certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority failing which they shall have no right for admission to EWSs category of the respective programme.
16. The candidates appearing in Final Round of Counseling/Mop-up Round in case they are offered a seat for admission, must have to deposit the requisite amount of fee except hostel charges in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC : SBIN0003632) at SBI, HPAU, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day.
17. If a candidate fails to register as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit, in the respective category. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
18. The vacancy position indicated above may vary and also arise of any category at the time of Final Round of Counseling/Mop-up Round for filling up.
19. The candidates selected for admission to M.Sc. Community Science programme through Final Round of Counseling/Mop-up Round shall have to register for the programme on the same day i.e. on 10.01.2023 upto 5.00 PM.
20. The classes for M.Sc. Community Science programme will commence w.e.f. 24.01.2023.
