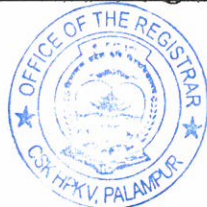

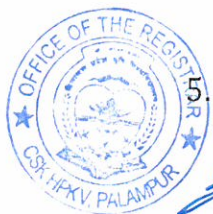

IMPORTANT INSTRUCTIONS TO THE CANDIDATES


1. The above final provisional select/waiting list for admission to B.Sc. (Hons.) Community Science programme is on the basis of the merit based subject to fulfilling the eligibility criteria for admission as well as availability of number of vacant seats for B.Sc. (Hons.) Community Science programme for the Academic Year 2021-22.
2. The provisional select list for 1st Round of Counseling-cum-Admission for all categories excluding SFS seats for admission to B.Sc. (Hons.) Community Science programme for the Academic Year 2021-22 containing all the instructions is being issued separately. The provisional select list for 2nd Round of Counseling-cum-Admission to B.Sc. (Hons.) Community Science programme for SFS seats and the seat(s) remained vacant of any category in 1st Round of Counseling-cum-Admission will immediately be issued after the 1st Round of Counseling-cum-Admission and available on the University website. Similarly, if there still remain vacant seat(s) of any category, the provisional select list for 3rd Round of Counseling-cum-Admission to B.Sc. (Hons.) Community Science programme for the respective category will be issued. The candidate shall have to check his/her name in the respective provisional select list of the concerned Round of Counseling-cum-Admission for B.Sc. (Hons.) (Hons.) Community Science programme shall be forfeited. No separate correspondence in this regard will be made.
3. The admission to B.Sc. (Hons.) Community Science programme shall be made as per the provisions contained in the Information Brochure & Prospectus Merit Based Admissions 2021-22 and subsequent notifications issued by the University.
4. Admissions under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure Prospectus Merit Based Admissions for the year 2021-22.
