The Hon'ble High Court of Himachal Pradesh, Shimla in CWP No.1500 of 2023 titled Sanchit Sahu Versus CSK H.P. Krishi Vishwavidyalaya, Palampur had stayed the counselling for grant of admission in M.Sc. Agronomy against the vacant seat of ICAR quota vide order dated 27.03.2023 and as a result of it, the counselling for Mop-Up Round for one vacant ICAR seat which was open to all eligible candidates in M.Sc. Agronomy as per Mop-Up Round Notice (Entrance Test Based Admissions 2022-23) No.7-2 (Admissions)/CSKHPKV (Acad.)/2022/14517-46 dated 22.03.2023 was not conducted on 28.03.2023 (By 11.00 AM).


Now, the Hon'ble High Court of Himachal Pradesh, Shimla in CWP No.1500 of 2023 dated 10.04.2023 titled Sanchit Sahu Versus CSK H.P. Krishi Vishwavidyalaya, Palampur on filling up of vacant ICAR seat on merit and in consequence thereto on becoming one seat vacant in Self Finance Scheme, has directed the University to fill up the vacant seat lying in self finance scheme as per merit within two days.

In pursuance of the above stay order dated 27.03.2023 and to honour the decision dated 10.04.2023 of the Hon'ble High Court of Himachal Pradesh, Shimla in CWP No.1500 of 2023 titled Sanchit Sahu Versus CSK H.P. Krishi Vishwavidyalaya, Palampur, **the CSK H.P. Krishi Vishwavidyalaya, Palampur has now decided to conduct the Mop-Up Round for one vacant seat of ICAR in M.Sc. Agronomy programme of this University for the Academic Year 2022-23 on 12.04.2023 (By 03.00 PM) on merit as per mode of admission and will be open to all eligible candidates for which the Mop-Up Round could not be held earlier on 28.03.2023 (By 11.00 AM) due to stay order of the Hon'ble High Court of Himachal Pradesh, Shimla. In case, the said seat is filled up from the candidates already admitted to M.Sc. Agronomy programme under Self Finance Seat of this University, the said Self Finance Seat become resultant vacant will be filled up on merit as per mode of admission.**

The terms and conditions for filling up the seat(s) in M.Sc. Agronomy programme shall remain the same as per Mop-Up Round Notice No.7-2(Admissions)/CSKHPKV (Acad.)/2022/14517-46 dated 22.03.2023 except the condition under Note at Sr. No. 15. It is also for the information of the candidates that if a candidate has not opted for Self-Financing seat at the time of filling online application form, his/her candidature for Self Financing seat shall not be considered in above mop-up round.


