GENERAL INSTRUCTIONS FOR COUNSELING

- 1. It is mandatory for the candidates as per Annexures to report in person for Counseling-cum-Registration & Admission-I to B.V.Sc. & A.H. programme to the Dean, Dr. G.C. Negi College of Veterinary & Animal Sciences, CSKHPKV, Palampur on 11.09.2023 by 11.30 AM and mark his/her attendance in the attendance sheet/register kept for the purpose. The candidature of the candidates reporting after 11.30 AM shall not be considered/entertained. The candidates on confirmation of admission to a seat through Counseling-cum-Registration & Admission-I shall have to pay fees and other charges except hostel charges on the same day at the time of counseling-cum-Registration & Admission in the office of the Dean, Dr. G.C.Negi, COVAS, CSKHPKV, Palampur upto 4.00 PM in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur or Account No.99930000001978 (IFSC: HDFC0001736) at HDFC Bank, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day to complete the admission process on the same day otherwise the seat will be declared vacant and his/her right for admission shall stand cancelled and he/she will not be eligible for admission. Also, if any candidate remains absent at the time of document verification, fee deposition the seat will be presumed to be vacant. Further, if a candidate refuses to accept admission at his/her own turn, he/she shall lose his/her right for admission to the programme. However, such candidates can appear in the final round of counseling/mop-up rounds of the programme.
- 2. For the process of verification of documents, the candidates shall have to show Admit Card of respective Entrance Test alongwith all the original certificates/documents relating to admission to the Counseling-cum-Registration & Admission Committee at the time of Counseling-cum-Registration & Admission-I and also to submit the counseling proforma at Annexure-IX duly filled in all respects, to be downloaded from the University website alongwith two copies of recent his/her photograph alongwith two sets of self-attested photocopies of the certificates/documents relating to admission, failing which the candidate shall have no right for admission to the programme.
- 3. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure IV as per medical and physical fitness standards prescribed in Annexure V of the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24 at the time of admission.
- 4. The admission under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure Prospectus

Entrance Test Based Admissions for the year 2023-24. The lists of candidates under Sports category is purely temporary. The merit of the candidates in sports category will be determined on the spot at the time Counseling-cum-Registration & Admission-I on the production of valid documents related to claim in sports category in original by the candidates.

- 5. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24.
- 6. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority at the time of counseling failing which they shall have no right for admission to EWSs category of the programme.
- 7. If a candidate fails to attend the Counseling on 11.09.2023 by 11.30 AM as per mode of admission, his/her candidature will be cancelled.
- 8. The admission to B.V.Sc. & A.H. programme shall be made as per the provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24 of the University.
- 9. While every care has been taken in preparing the select/waiting lists for Counseling-cum-Registration & Admission-I to above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
