

IMPORTANT INSTRUCTIONS TO THE CANDIDATES

1. The above provisional select/waiting list for admission to B.V.Sc. & A.H. programme is on the basis of merit score of NEET (UG)-2023 and subject to fulfilling the eligibility criteria for admission as well as availability of number of seats for B.V.Sc. & A.H. programme for the Academic Year 2023-24.
2. Where two or more candidates have obtained equal marks in the respective entrance test, their merit will be decided on the basis of rank in the respective entrance tests as declared by NTA for admission to the respective programme. In the eventuality of same rank, the merit would be decided on the basis of percentage of aggregate marks obtained in the concerned subjects of the qualifying examination. If there is still a tie, then the candidate older in age will be considered higher in the merit. Accordingly, the select /waiting list of the candidates who have obtained equal marks in the NEET (UG)-2023 is purely tentative. The merit of the candidates in such cases for admission will be decided at the time of respective Counseling-cum-Registration & Admission rounds and the candidate(s) higher in merit as per mode of admission will be admitted after scrutinizing his original certificates/documents including rank card of NEET (UG)-2023 relating to admission on the spot by the counseling-cum-registration & admission committee.
3. **The provisional select list for Counseling-cum-Registration & Admission-I for all categories including SFS seats for admission to B.V.Sc. & A.H. programme for the Academic Year 2023-24 containing all the instructions is being issued separately.** The provisional select list for Counseling-cum-Registration & Admission-I for B.V.Sc. & A.H. programme for all category seats and the seat(s) remained vacant of any category in Counseling-cum-Registration & Admission-I for Counseling-cum-Registration & Admission-II will immediately be issued after the Counseling-cum-Registration & Admission-I and available on the University website. Similarly, if there still remain vacant seat(s) of any category, the provisional select list after Counseling-cum-Registration & Admission-II for B.V.Sc. & A.H. programme for the respective category will be issued for the Final Round of counseling/Mop-up round. The candidate shall have to check his/her name in the respective Counseling-cum-Registration & Admission for B.V.Sc. & A.H. programme and shall have to appear before the Counseling-cum-Registration & Admission Committee on the scheduled date, time and venue for respective Counseling-cum-Registration & Admission failing which his/her right for admission including in the subsequent round of Counseling-cum-Registration & Admission for B.V.Sc.& A.H. programme shall be forfeited. No separate correspondence in this regard will be made.
4. The admission to B.V.Sc. & A.H. programme shall be made as per the provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24 and subsequent notifications issued by the University.
5. Admissions under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24. **The lists of candidates under Sports category is purely temporary. The merit of the candidates in sports category will be determined on the spot at the time Counseling-cum-Registration & Admission-I on the production of valid documents related to claim in sports category in original by the candidates.**
