1. The above provisional select/waiting list for admission to B.Sc. (Hons.) Agriculture programme is on the basis of the merit and purely temporary. If any candidate has any objection or finds that his/her name is missing in the above shortlisted list, he/she is free to point out the same upto 04.12.2023 by 10.00 AM by writing to the Registrar, CSKHPKV, Palampur through e-mail contactpetcskhpkv@gmail.com by mentioning his/her application number and name failing which no claim/representation of the candidate will be entertained thereafter.
2. The candidates should have to ensure that for admission to the B.Sc. (Hons.) Agriculture programme, they should have appeared in CUET (ICAR-UG)-2023 with atleast three subjects out of Physics, Chemistry, Mathematics, Biology and Agriculture i.e. only the subjects which have been studied and passed by him/her in the qualifying examination (12th standard) otherwise their candidature will not be considered. The candidature of the candidates who have not appeared in CUET (ICAR-UG)-2023 or not opted for CUET (ICAR-UG)-2023 or attempted different subject combination in CUET (ICAR-UG)-2023 than that studied and passed in the 12th standard examination will not be considered for Counseling/Admission and will be rejected. Accordingly, the admissions to B.Sc. (Hons.) Agriculture programme will be made.
3. After verification of the objection(s), if any, raised/pointed out by the candidate(s), the final provisional select list/waiting list for counseling to B.Sc. (Hons.) Agriculture programme will be issued separately which shall be available on the University website <http://hillagric.ac.in> containing all the instructions/procedure for Counseling-cum-Registration & Admission-I to B.Sc. (Hons.) Agriculture programme. If any correction/error is noticed during verification, the same shall also be rectified by the University for which no objection will be entertained.
4. The admissions to B.Sc. (Hons.) Agriculture programme will be made as per the provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24.

5. While every care has been taken in preparing the select/waiting list for the above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserved the right to rectify the same later on.
