## IMPORTANT INSTRUCTIONS TO THE CANDIDATES

1. It is mandatory for all the candidates as per Annexure to report in person for Counseling-cum-Registration & Admission-I to above said programme to the Dean, College of Agriculture, CSKHPKV, Palampur on 11.12.2023 by 11.30 AM and mark his/her attendance in the attendance sheet/register kept for the purpose, otherwise his/her candidature shall not be entertained and his/her candidates reporting after 11.30 AM shall not be considered/entertained. The candidates reporting after 11.30 AM shall not be considered/entertained. The Registration & Admission-I process, shall have to deposit the requisite fee and claim for said seat shall be forfeited and he/she shall have no right for his/her admission from the waiting list to be issued by University. However, such round for admission to the respective programme.

2. The candidates should have to ensure that for admission to the B.Sc. (Hons.) Agriculture programme, they should have appeared in CUET (ICAR-UG)-2023 with atleast three subjects out of Physics, Chemistry, Mathematics, Biology and Agriculture i.e. only the subjects which have been studied and passed by him/her in the qualifying examination (12th standard) otherwise their candidature will not be considered. The candidature of the candidates who have not appeared in CUET (ICAR-UG)-2023 or not opted for CUET (ICAR-UG)-2023 or attempted different subject combination in CUET (ICAR-UG)-2023 than that studied and

passed in the 12th standard examination will not be considered for Counseling/Admission and will be rejected. Only the percentile score in the concerned subjects of CUET (ICAR-UG)-2023 will be considered/taken for calculating the CUET (ICAR-UG)-2023 score after verification by the Counseling-cum-Registration & Admission Committee for admission to B.Sc. (Hons.) Agriculture programme. Accordingly, the admissions to B.Sc. (Hons.) Agriculture programme will be made by the Counseling-cum-Registration & Admission Committee.

- 3. The Counseling-cum-Registration and Admission-I to the programme will be made first to all the category seats except Self Financing Seats followed by conthe same day.

- 4. Admissions under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24 and hence the list under Sports/Co-curricular activities is tentative.
- 5. For the process of verification of documents, the candidates shall have to show Admit Card of respective Entrance Test alongwith all the original certificates/documents relating to admission to the Counseling-cum-Registration & Admission-I and also submit the counseling proforma at Annexure-IX duly copies of recent his/her photograph alongwith two sets of self-attested photocopies of the certificates/document relating to admission, at the time of admission to the programme.
- The candidates on confirmation of admission to a seat through Counseling-cum-6. Registration & Admission-I shall have to pay fees and other charges except hostel charges on the same day at the time of Counseling-cum-Registration & Admission-I in the office of the Dean, College of Agriculture, CSKHPKV, Palampur upto 4.00 PM in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur or Account No.99930000001978 (IFSC: HDFC0001736) at HDFC Bank, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day in the office of the Dean, College of Agriculture, CSKHPKV, Palampur to complete the admission process on the same day otherwise the seat will be declared vacant and his/her right for admission shall stand cancelled and he/she will not be eligible for admission. Also, if any candidate remains absent at the time of document verification, fee deposition, the seat will be presumed to be vacant. Further, if a candidate refuses to accept admission at his/her own turn, he/she shall lose his/her right for admission to the programme. However, such candidates can appear in the final round of counseling/mop-up rounds of the programme. 7.
- 7. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24.

The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority at the time of counseling failing which they shall have no right for admission to EWSs category of B.Sc.(Hons.) Agriculture
