Agriculture programme at the time of final round of counseling/mop up round, these will be converted to Self-Financing Seats (SFS) on the spot and will be filled up by the University on merit as per mode of admission at the time of final round of counseling/mop-up round.*

*If the seats of Wards of Kashmiri Migrant and Kashmiri Pandits/Kashmiri Hindu families (non-migrants) and PM-USP for UT of J & K and Ladakh remain vacant in B.Sc. (Hons.) Agriculture programme at the time of Final Round of Counseling/Mop-up Round, these will be converted to Self Financing Seat(s) on the spot and will be filled up at the time of Final Round of Counseling/Mop-up Round.*

**Note:**


1. **No separate communication will be made.**
2. **All the candidates who appeared in CUET (ICAR-UG)-2023 and filled the online application form with requisite application fee for admission to B.Sc. (Hons.) Agriculture programme of this University will only be entitled to appear in final round of counseling /mop-up round for admission to B.Sc. (Hons.) Agriculture programme.**
3. **The candidates should have to ensure that for admission to the B.Sc. (Hons.) Agriculture programme, they should have appeared in CUET (ICAR-UG)-2023 with atleast three subjects out of Physics, Chemistry, Mathematics, Biology and Agriculture i.e. only the subjects which have been studied and passed by him/her in the qualifying examination (12<sup>th</sup> standard) otherwise their candidature will not be considered. The candidature of the candidates who have not appeared in CUET (ICAR-UG)-2023 or not opted for CUET (ICAR-UG)-2023 or attempted different subject combination in CUET (ICAR-UG)-2023 than that studied and passed in the 12<sup>th</sup> standard examination will not be considered for Counseling/Admission and will be rejected. Only the percentile score in the concerned subjects of CUET (ICAR-UG)-2023 will be considered/taken for calculating the CUET (ICAR-UG)-2023 score after verification by the Counseling-cum-Registration & Admission Committee at the time of final round of counseling/mop-up round for admission to B.Sc. (Hons.) Agriculture programme. Accordingly, the admissions to B.Sc. (Hons.) Agriculture programme will be made by the Counseling-cum-Registration & Admission Committee at the time of final round of counseling/mop-up round.**
4. **The eligible candidates desiring to take admission through final round of counseling/mop-up round will have to appear for the final round of counseling/mop-up round of B.Sc. (Hons.) Agriculture programme on the specified date and venue upto 11.00 A.M. for counseling. Such candidates shall have to mark their attendance in the attendance sheet/register kept there for the purpose positively by 11.00 A.M.**
5. **Admissions under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24.**
6. **The admissions through Final Round of Counseling/Mop-up Round will be made as per provisions contained in Information Brochure & Prospectus Entrance Test Based Admissions 2023-24 and subsequent notifications issued by the University.**
7. **The candidature of the candidate to the programme will only be considered against the specific category for admission as he/she has applied for the said category at the time of filling online application form.**
8. **If a candidate has not opted for Self-Financing seat at the time of filling online application form, his/her candidature for Self Financing seat shall not be**

considered in Final Round of Counseling/Mop-up Round for B.Sc. (Hons.) Agriculture programme.

9. In case of non-availability of HP Bonafide candidates, the candidature of Non-H.P. Bonafide candidates can be considered against the vacant seat(s) of HP Bonafide category, if any, at the time of Final Round of Counseling/Mop-Up Round. In such cases, the candidates shall have to attend the Final Round of Counseling/Mop-up Round.
10. The candidates shall have to show all original certificates/documents relating to admission to the Counseling-cum-Admission Committee of the University at the time of Final Round of Counseling/Mop-up Round. Simultaneously, the candidate shall have also to submit two copies of his/her recent photograph and two sets of self-attested copies of all the relevant certificates/documents (as mentioned in the Counseling Proforma) relating to admission alongwith counseling proforma at Annexure IX of the Information Brochure and Prospectus Entrance Test Based Admissions 2023-24 (to be downloaded from the University Website <http://hillagric.ac.in>) duly filled in all respects, at the time of document verification to the Counseling-cum-Admission Committee for admission through Final Round of Counseling/Mop-up Round of the respective programme.
11. The admission shall be made on the basis of merit list as per mode of admission to be drawn on the day of Final Round of Counseling/Mop-up Round.
12. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure IV as per medical and physical fitness standards prescribed in Annexure V of the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24 at the time of Final Round of Counseling/Mop-up Round.
13. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Entrance Test Based Admissions 2023-24.
14. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset Certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority failing which they shall have no right for admission to EWSs category of the respective programme.
15. The candidates appearing in Final Round of Counseling/Mop-up Round in case they are offered a seat for admission, must have to deposit requisite amount of fee except hostel charges in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC : SBIN0003632) at SBI, HPAU, Palampur or Account No.99930000001978 (IFSC : HDFC0001736) at HDFC Bank, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day in the office of the Dean, College of Agriculture, CSKHPKV, Palampur.
16. If a candidate fails to register as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
17. The candidates selected for admission to B.Sc. (Hons.) Agriculture programme through Final Round of Counseling/Mop-up Round shall have to register for the programme on same day upto 5.00 PM.
18. The vacancy position indicated above may vary and also arise of any category at the time of Final Round of Counseling/Mop-up Round for filling up.

19. While every care has been taken in preparing the lists for Final Round of Counseling/Mop-up Round to above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
