- (iii) All India rank/Overall Rank obtained by the candidate in NEET (UG)-2023 (If available);
- (iv) Shall have also to upload score card of entrance test NEET (UG)-2023.

The candidates shall have to complete the above process within the stipulated time failing which his/her right for admission to the B.V.Sc. & A.H programme shall stand forfeited and no correspondence in this regard will be made. **The candidate must ensure that he/she furnished the correct 1) Roll Number issued by National Testing Agency, 2) Total Marks obtained, ALL INDIA RANK/OVERALL RANK obtained in NEET (UG)-2023 in his/her online application form failing which his/her candidature for admission will not be considered and the individual will be solely responsible for it.** At this time, no candidate shall be allowed to rectify/add/modify their information/particulars already filled in their online application form.
