The candidate must ensure that he/she furnished the correct 1) Roll Number issued by National Testing Agency, 2) Total Marks obtained, ALL INDIA RANK/OVERALL RANK obtained in NEET (UG)-2023 in his/her online application form failing which his/her candidature for admission will not be considered and the individual will be solely responsible for it.
