It is hereby notified that on the basis of the recommendations of Counseling-cum-Admission Committee of the counseling conducted to B.Sc. Life Sciences (Botany, Zoology & Chemistry) programme on 15.07.2023, the candidates as per lists categorywise attached with the notification shall have to report for Registration-cum-Admission-I for the Academic Year 2023-24 on 25.07.2023 by 11.30 AM to the Dean, College of Basic Sciences, CSKHPKV, Palampur and on confirmation of his/her admission against the seat shall have to deposit the requisite fee and get himself/herself registered by 4.00 PM on the same day. The Registration-cum-Admission-I shall be subject to the following conditions and important instructions to the candidates:

- 1. It is mandatory for the candidates as per lists enclosed with the notification to report in person for Registration-cum-Admission-I to the Dean, College of Basic Sciences, CSKHPKV, Palampur on 25.07.2023 by 11.30 AM positively and mark his/her attendance in the attendance sheet/register kept for the purpose. The candidature of the candidates reporting after 11.30 AM shall not be considered/entertained.
- 2. The lists of candidates for the programme is on the basis of merit and categorywise as per mode of admission.
- 3. The candidate who finds himself/herself selected through Registration-cum-Admission-I process shall have to deposit the requisite fee except hostel charges directly in the Comptroller's Account No: 32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or any other bank transaction at the time of Registration-cum-Admission-I on 25.07.2023 upto 4.00 PM failing which the seat will be declared vacant and his/her right for admission shall stand cancelled. Also, if any candidate remains absent at the time of fee deposition, the seat will be presumed to be vacant. Further, if a candidate refuses to accept admission at his/her own turn, he/she shall lose his/her right for admission to the programme. Such candidates shall have also no right for his/her admission from the waiting list to be issued by the University.
- 4. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure V as per medical and physical fitness standards prescribed in Annexure VI of the Information Brochure & Prospectus Merit Based Admissions 2023-24 at the time of admission.

- 5. The admission to the programme through Registration-cum-Admission-I is subject to availability of seats categorywise and completion of admission formalities.
- 6. The admission to the programme through Registration-cum-Admission-I shall be made as per the provisions contained in the Information Brochure & Prospectus Merit Based Admissions 2023-24.
- 7. At the time of admission and in the subsequent years, every student shall be required to fill <u>online Anti Ragging Undertaking</u> at www.amanmovement.org (OR) w.w.w.antiragging.in.
- 8. The classes to the programme will commence w.e.f. 07.08.2023.
- 9. While every care has been taken in preparing the select/waiting lists for the above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
