GENERAL INSTRUCTIONS FOR COUNSELING

- 1. It is mandatory for all the candidates as per Annexures to report in person for counseling to B.Sc. (Hospitality & Hotel Administration) programme to the Dean, College of Community Science, CSKHPKV, Palampur on 13.07.2023 at 10.00 AM to 04.00 PM and mark his/her attendance in the attendance sheet/register kept for the purpose otherwise his/her candidature shall not be entertained and his/her right to admission shall be forfeited.
- 2. All original certificates/documents for admission to B.Sc. (Hospitality & Hotel Administration) programme must be shown to the Counseling Committee of the University by the candidates at the time of counseling. Simultaneously, the candidates shall have also to submit two copies of his/her recent photograph and two sets of self-attested photocopies of all the relevant certificates/documents (as mentioned in the counseling Proforma) relating to admission alongwith counseling Proforma (Annexure II) duly filled in all respects, at the time of document verification with the Counseling Committee.
- 3. After counselling the candidates maximum 3-5 times of the total intake capacity in each category of the programme, in order of merit as per mode of admission shall be called on the date of Registration-cum-Admission-I to report by 11.30 AM. The list of such candidates will be available on the University website before the date of Registration-cum-Admission-I containing all the instructions for Registration-cum-Admission-I.
- 4. The admission under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure Prospectus Merit Based Admissions for the year 2023-24.
- 5. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Merit Based Admissions 2023-24.
- 6. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority at the time of counseling failing which they shall have no right for admission to EWSs category of B.Sc. (Hons.) Community Science programme.
- 7. If a candidate fails to attend the Counseling on 13.07.2023 (10.00 AM to 4.00 PM) as per mode of admission, his/her candidature will be cancelled.

- 8. The admission to B.Sc. (Hospitality & Hotel Administration) programme shall be made as per the provisions contained in the Information Brochure & Prospectus Merit Based Admissions 2023-24 of the University.
- While every care has been taken in preparing the select/waiting lists for counseling to above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
