(Hons./Hons. with Research) Life Sciences (Botany/Zoology/Chemistry) programme for the Academic Year 2024-25 on 26.07.2024 by 11.30 AM to the Dean, College of Basic Sciences, CSKHPKV, Palampur and on confirmation of his/her admission against the seat shall have to deposit the requisite fee and get himself/herself registered by 4.00 PM on the same day. The Registration-cum-Admission-II shall be subject to the following conditions and important instructions to the candidates:


1. It is mandatory for the candidates as per list enclosed with the notification to report in person for Registration-cum-Admission-II to the Dean, College of Basic Sciences, CSKHPKV, Palampur on 26.07.2024 by 11.30 AM positively and mark his/her attendance in the attendance sheet/register kept for the purpose. The candidature of the candidates reporting after 11.30 AM shall not be considered/entertained.
2. The list of candidates for the programme is on the basis of merit as per mode of admission.
3. The candidate who finds himself/herself selected through Registration-cum-Admission-II process shall have to deposit the requisite fee except hostel charges directly in the Comptroller's Account No: 32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur or Account No.99930000001978 (IFSC : HDFC0001736) at HDFC Bank, Palampur through internet banking or any other bank transaction at the time of Registration-cum-Admission-II and submit the computer generated receipt or bank receipt as a proof of deposit of fee in the Office of the concerned Dean on 26.07.2024 upto 4.00 PM. The candidate can also deposit the fee by way of demand draft drawn in favour of Comptroller, CSKHPKV, Palampur payable at SBI, HPAU, Palampur (Code 0003632) or payable at Palampur and submit the said draft in the office of the concerned Dean at the time of Registration-cum-Admission-II failing which the seat will be

declared vacant and his/her right for admission shall stand cancelled. Also, if any candidate remains absent at the time of fee deposition, the seat will be presumed to be vacant. Further, if a candidate refuses to accept admission at his/her own turn, he/she shall lose his/her right for admission to the programme. However, such candidates can participate/take part in the final round of counseling/mop round for admission to the respective programme.

4. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure V as per medical and physical fitness standards prescribed in Annexure VI of the respective Information Brochure & Prospectus Merit Based Admissions 2024-25 at the time of admission.
5. The admission to the programme through Registration-cum-Admission-II is subject to availability of seats and completion of admission formalities.
6. The admission to the programme through Registration-cum-Admission-II shall be made as per the provisions contained in the respective Information Brochure & Prospectus Merit Based Admissions 2024-25.
7. At the time of admission and in the subsequent years, every student shall be required to fill online Anti Ragging Undertaking at www.amanmovement.org (OR) w.w.w.antiragging.in.
8. The classes to the programme will commence w.e.f. 01.08.2024.
9. While every care has been taken in preparing the list for Registration-cum-Admission-II for the above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
