Agriculture programme, they should have appeared in CUET (UG)-2024 with atleast three subjects out of Physics, Chemistry, Mathematics, Biology and Agriculture i.e. only the subjects which have been studied and passed by him/her in the qualifying examination (12th standard) otherwise their candidature will not be considered. Only the marks obtained in the concerned subjects of CUET (UG)-2024 will be considered/taken for calculating the CUET (UG)-2024 score.
- 3. After verification of the objection(s), if any, raised/pointed out by the candidate(s), the final provisional select list/waiting list for counseling to B.Sc. (Hons.) Agriculture programme will be issued separately which shall be available on the University website http://hillagric.ac.in containing all the instructions/procedure for Counseling-cum-Registration & Admission-I to B.Sc. (Hons.) Agriculture programme. If any correction/error is noticed during verification, the same shall also be rectified by the University for which no objection will be entertained.
- The admissions to B.Sc. (Hons.) Agriculture programme will be made as per the provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25.
