Only the marks obtained in the concerned subjects of CUET (UG)-2024 will be considered/taken for calculating the CUET (UG)-2024 score.
- 3. After verification of the objection(s), if any, raised/pointed out by the candidate(s), the final provisional select list/waiting list for counseling to B.Tech. (Food Technology) programme will be issued separately which shall be available on the University website http://hillagric.ac.in containing all the instructions/procedure for Counseling-cum-Registration & Admission-I to B.Tech. (Food Technology) programme. If any correction/error is noticed during verification, the same shall also be rectified by the University for which no objection will be entertained.
