GENERAL INSTRUCTIONS FOR COUNSELING-cum-REGISTRATION & ADMISSION-II

1. It is mandatory for all the candidates as per Annexures to report in person for Counseling-cum-Registration & Admission-II to above said programme to the Dean, College of Agriculture, CSKHPKV, Palampur on 04.10.2024 by 11.30 AM and mark his/her attendance in the attendance sheet/register kept for the purpose otherwise his/her candidature shall not be entertained and his/her right to admission to the programme shall be forfeited. The candidature of the candidates reporting after 11.30 AM shall not be considered/entertained. The candidate(s) who finds himself/herself selected through Counseling-cum-Registration & Admission-II process shall have to deposit the requisite fee and get himself/herself registered by 4.00 PM on the same day failing which his/her claim for said seat shall be forfeited. However, such candidates can participate/take part in the final round of Counseling/Mop-up round for admission to the respective programme.

The candidates should have to ensure that for admission to B.Sc. (Hons.) Agriculture programme, they should have appeared in CUET (UG)-2024 with atleast three subjects out of Physics, Chemistry, Mathematics, Biology and Agriculture i.e. only the subjects which have been studied and passed by him/her in the qualifying examination (12th standard). Only the marks obtained in the concerned subjects of CUET (UG)-2024 will be considered/taken for calculating the CUET (UG)-2024 score otherwise their candidature will not be considered.





Accordingly, the admissions to B.Sc. (Hons.) Agriculture programme will be made by the Counseling-cum-Registration & Admission Committee.

The Counseling-cum-Registration and Admission-II to the programme will be 3. made first to all the category seats except Self Financing Seats followed by Counseling-cum-Registration and Admission-II to Self Financing Seats at the end

on the same day.

The admission under Sports/Co-curricular activities sub category will be 4. governed as per criteria mentioned in Annexure-I of the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25 at the time of counseling and hence the list under Sports/Co-curricular activities is tentative. It will be in the interest of the candidates applied under this category to show their certificates of Sports/Co-curricular activities duly verified from the concerned competent sports authority, to the Counseling cum Admission Committee at the time of Counseling in order to avoid confusion/authenticity of said certificate(s).

For the process of verification of documents, the candidates shall have to show alongwith all the Admit Card of respective Entrance Test Counseling-cumrelating to admission to certificates/documents Registration & Admission Committee at the time of Counseling-cum-Registration & Admission-II and also submit the counseling proforma at Annexure-IX duly filled in all respects, to be downloaded from the University website alongwith two copies of his/her recent photograph alongwith two sets of self-attested photocopies of the certificates/documents relating to admission, at the time of document verification, failing which the candidate shall have no right for

admission to the programme.

The candidates on confirmation of admission to a seat through Counseling-cum-Registration & Admission-II shall have to deposit the requisite fees and other 6. charges except hostel charges on the same day at the time of Counseling-cum-Registration & Admission-II in the office of the Dean, College of Agriculture, CSKHPKV, Palampur upto 4.00 PM, in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur or Account No.99930000001978 (IFSC: HDFC0001736) at HDFC Bank, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day in the office of the Dean, College of Agriculture, CSKHPKV, Palampur to complete the admission process on the same day otherwise the seat will be declared vacant and his/her right for admission shall stand cancelled and he/she will not be eligible for admission. Also, if any candidate remains absent at the time of document verification, fee deposition, the seat will be presumed to be vacant. Further, if a candidate refuses to accept admission at his/her own turn, he/she shall lose his/her right for admission to the programme. However, such candidates can appear in the final round of counseling/mop-up round of the programme.

If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the 7. admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure &

Prospectus Entrance Test Based Admissions 2024-25.

If a candidate from the list at Annexures fails to attend the Counseling for B.Sc. (Hons.) Agriculture programme on 04.10.2024 by 11.30 AM as per mode of 8. admission, his/her candidature will be cancelled.

The admission to B.Sc. (Hons.) Agriculture programme shall be made as per the provisions contained in the Information Brochure & Prospectus Entrance Test 9. Based Admissions 2024-25 of the University and subsequent notifications issued by the University.

10. While every care has been taken in preparing the lists for Counseling-cum-Registration & Admission-II to above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
