- i) *The vacant seats will be filled categorywise on merit at the time of final round of counseling/mop-up round for B.Sc. (Hons.) Agriculture programme. If the seats in any category {except the category of ICAR, Wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (non migrant), in-service nominee of H.P. Government/CSKHPKV Palampur nominee, PM-USP for UT of J & K and Ladakh and Self-financing seats} remain vacant due to non-availability of eligible candidates, will be added to general category at the time of final round of counseling / mop-up round on the spot and filled up accordingly. During this process, if seats of H.P. Bonafide remain vacant, the non-HP Bonafide candidates can also be considered.*
- ii) *In case, seat(s) of in-service nominee of H.P. Government/CSKHPKV, Palampur nominee/ICAR nominee remain vacant in B.Sc. (Hons.) Agriculture programme at the time of final round of counseling/mop up round, these will be converted to Self-Financing Seats (SFS) on the spot and will be filled up by the University on merit as per mode of admission at the time of final round of counseling/mop-up round.*
- iii) *If the seat of Ward of Kashmiri Migrant and Kashmiri Pandits/Kashmiri Hindu families (non-migrants) and PM-USP for UT of J & K and Ladakh in B.Sc. (Hons.) Agriculture programme remain vacant at the time of Final Round of Counseling/Mop-up Round, such seat(s) shall be converted to Self Financing Seat(s) on the spot and will be filled up at the time of Final Round of Counseling/ Mop-up Round.*

IMPORTANT INSTRUCTIONS TO THE CANDIDATES :

1. **No separate communication will be made.**
2. **All the candidates who appeared in CUET (UG)-2024 and filled the online application form with requisite application fee for admission to B.Sc. (Hons.) Agriculture Programme of the University will only be entitled to appear in final round of counseling /mop-up round for admission to B.Sc. (Hons.) Agriculture programme.**
3. **The eligible candidates wishing to take admission through final round of counseling/mop-up round will have to appear for the final round of counseling/mop-up round of B.Sc. (Hons.) Agriculture programme at College of Agriculture, CSKHPKV, Palampur on 15.10.2024 upto 11.00 A.M. for counseling. Such candidates shall have to mark their attendance in the attendance sheet/register kept there for the purpose positively by 11.00 A.M. The candidature of the candidate reporting after 11.00 A.M. will not be considered.**
4. **The candidates should have to ensure that for admission to B.Sc. (Hons.) Agriculture programme, they should have appeared in CUET (UG)-2024 with atleast three subjects out of Physics, Chemistry, Mathematics, Biology and Agriculture i.e. only the subjects which have been studied and passed by him/her in the qualifying examination (12th standard). Only the marks obtained in the concerned subjects of CUET (UG)-2024 will be considered/taken for calculating the CUET (UG)-2024 score otherwise their candidature will not be considered. Accordingly, the admissions to B.Sc. (Hons.) Agriculture programme will be made by the Counseling-cum-Registration & Admission Committee.**
5. **The admissions through Final Round of Counseling/Mop-up Round will be made as per provisions contained in Information Brochure & Prospectus Entrance Test Based Admissions 2024-25 and subsequent notifications issued by the University.**
6. **The candidature of the candidate to the programme will only be considered against the specific category for admission as he/she has applied for the said category at the time of filling online application form.**
7. **If a candidate has not opted for Self-Financing seat at the time of filling online application form, his/her candidature for Self Financing seat shall not be considered in Final Round of Counseling/Mop-up Round for B.Sc. (Hons.) Agriculture programme.**

8. In case of non-availability of HP Bonafide candidates, the candidature of Non-H.P. Bonafide candidates can be considered against the vacant seat(s) of HP Bonafide category, if any, at the time of Final Round of Counseling/Mop-Up Round. In such cases, the candidates shall have to attend the Final Round of Counseling/Mop-up Round.
9. The candidates shall have to show Admit Card of respective Entrance Test alongwith all original certificates/documents relating to admission to the Counseling-cum-Admission Committee of the University at the time of Final Round of Counseling/Mop-up Round for B.Sc. (Hons.) Agriculture programme. Simultaneously, the candidate shall have also to submit two copies of his/her recent photograph and two sets of self-attested copies of all the relevant certificates/documents (as mentioned in the Counseling Proforma) relating to admission alongwith counseling proforma at Annexure IX of the Information Brochure and Prospectus Entrance Test Based Admissions 2024-25 (to be downloaded from the University Website <http://hillagric.ac.in>) duly filled in all respects, at the time of document verification to the Counseling-cum-Admission Committee for admission through Final Round of Counseling/Mop-up Round of the respective programme.
10. The admission shall be made on the basis of merit list as per mode of admission to be drawn on the day of Final Round of Counseling/Mop-up Round.
11. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure IV as per medical and physical fitness standards prescribed in Annexure V of the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25 at the time of Final Round of Counseling/Mop-up Round.
12. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25.
13. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset Certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority failing which they shall have no right for admission to EWSs category of the respective programme.
14. The candidates appearing in Final Round of Counseling/Mop-up Round in case they are offered a seat for admission, must have to deposit requisite amount of fee except hostel charges in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC : SBIN003632) at SBI, HPAU, Palampur or Account No.99930000001978 (IFSC : HDFC0001736) at HDFC Bank, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day.
15. If a candidate fails to register as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
16. The vacancy position indicated above may vary and also arise of any category at the time of Final Round of Counseling/Mop-up Round for filling up.
17. While every care has been taken in preparing the Final Round of Counseling/Mop-up Round Notice to above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
