Community Science programmes of Entrance Test Based Admissions 2024-25 of CSK Himachal Pradesh Krishi Vishwavidyalaya, Palampur shall be filled up through Final Round of Counseling/Mop-up Round for the Academic Year 2024-25 to be held on 02.12.2024 by 11.00 AM in the office of the Dean, Postgraduate Studies, CSKHPKV, Palampur:

If the seats in any category {except the categories of ICAR, Wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu Families (Non-Migrants), In-service Nominee of H.P. Government, In-service Nominee of CSKHPKV, Palampur, Fellowship Awardee, NRI/OCI/Foreign Nationals and Self Financing Seat} remain vacant due to non availability of eligible candidates, will be added to General category at the time of Final

Round of Counseling/Mop-up Round on the spot subject to condition that where such seats remain vacant in Masters' programmes at the college level will be clubbed and allotted amongst the disciplines of concerned college proportionately under general category by the Counseling Committee on the spot and filled up accordingly.

Note:

1. **No separate communication will be made.**
2. **All the candidates who appeared in ICAR All India Entrance Examination for Admission (PG)-2024 and filled the online application form with requisite application fee for admission to M.Sc. Agriculture/M.Sc. Basic Sciences / M.Sc. Community Science programmes of this University will only be entitled to appear in the final round of counseling/mop-up round for admission to the respective Master programme of the University.**
3. **It is also for information to the candidates that the order of preference for admission in different disciplines of Masters in Agriculture shall be as under:**
 - i) **1st Preference: B.Sc. (Hons.) Agriculture/B.Sc. Agriculture**
 - ii) **2nd Preference: B.Sc. (Hons.) {Horticulture/Forestry/Sericulture}/B.Sc. {Horticulture/Forestry/Sericulture}**

Accordingly, the admissions to M.Sc. Agriculture programme will be made through Final Round of Counseling/Mop-up Round by the Counseling-cum-Registration & Admission Committee.
4. **The eligible candidates wishing to take admission through final round of counseling/mop-up round will have to appear for the final round of counseling/mop-up round of the respective Master's programmes on the specified date and venue upto 11.00 A.M. for counseling. Such candidates shall have to mark their attendance in the attendance sheet/register kept there for the purpose positively by 11.00 A.M.**
5. **The admissions through Final Round of Counseling/Mop-up Round will be made as per provisions contained in Information Brochure & Prospectus Entrance Test Based Admissions 2024-25 and subsequent notifications issued by the University.**
6. **The candidature of the candidate to the programme will only be considered against the specific category for admission as he/she has applied for the said category at the time of filling online application form.**
7. **If a candidate has not opted for Self-Financing seat at the time of filling online application form, his/her candidature for Self Financing seat shall not be considered in Final Round of Counseling/Mop-up Round for the respective Master programme.**
8. **In case of non-availability of HP Bonafide candidates, the candidature of Non-H.P. Bonafide candidates can be considered against the vacant seat(s) of HP Bonafide category, if any, at the time of Final Round of Counseling/Mop-Up Round. In such cases, the candidates shall have to attend the Final Round of Counseling/Mop-up Round.**
9. **The admission of the candidate will be considered in the same discipline(s) of Master's programme of this University i.e. in the sub-subject of Major Subject Groups of ICAR AIEEA (PG)-2024 in which he/she appeared in ICAR AIEEA (PG)-2024. However, if the seats in Master's programmes remain vacant at the time of final counseling/Mop-up round, the said seats will be filled up on spot from AIEEA (PG)-2024 on merit irrespective of major subject groups and sub-subject of AIEEA (PG)-2024.**
10. **Where two or more candidates have obtained equal marks in the respective entrance test, their merit will be decided on the basis of rank in the respective entrance test as declared by NTA/ICAR for admission to the respective programme. In the eventually of same rank or where rank not awarded, the merit will be decided on the basis of performance in the qualifying examination. If there is still a tie, then the candidate older in age will be considered higher in the merit.**

11. Admissions under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25.
12. The candidates shall have to show all original certificates/documents relating to admission to the Counseling-cum-Admission Committee of the University at the time of Final Round of Counseling/Mop-up Round. Simultaneously, the candidate shall have also to submit two copies of his/her recent photograph and two sets of self-attested copies of all the relevant certificates/documents (as mentioned in the Counseling Proforma) relating to admission alongwith counseling proforma at Annexure IX of the Information Brochure and Prospectus Entrance Test Based Admissions 2024-25 (to be downloaded from the University Website <http://hillagric.ac.in>) duly filled in all respects, at the time of document verification to the Counseling-cum-Admission Committee for admission through Final Round of Counseling/Mop-up Round of the respective programme.
13. The admission shall be made on the basis of merit list as per mode of admission to be drawn on the day of Final Round of Counseling/Mop-up Round.
14. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure IV as per medical and physical fitness standards prescribed in Annexure V of the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25 at the time of Final Round of Counseling/Mop-up Round.
15. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Entrance Test Based Admissions 2024-25.
16. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset Certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority failing which they shall have no right for admission to EWSs category of the respective programme.
17. The candidates appearing in Final Round of Counseling/Mop-up Round in case they are offered a seat for admission, must have to deposit requisite amount of fee except hostel charges in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC : SBIN0003632) at SBI, HPAU, Palampur or Account No.99930000001978 (IFSC : HDFC0001736) at HDFC Bank, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day in the office of the Dean, Postgraduate Studies, CSKHPKV, Palampur.
18. If a candidate fails to register as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
19. The candidates selected for admission to Master's programme through Final Round of Counseling/Mop-up Round shall have to register for the programme on same day upto 04.00 PM.
20. The vacancy position indicated above may vary and also arise of any category at the time of Final Round of Counseling/Mop-up Round for filling up.
21. While every care has been taken in preparing the Final Round of Counseling/

Mop-up Round Notice to above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
